2011 FALL SOFTBALL LEAGUE ENTRY FORM

_____ **MEN'S OPEN I (Competitive) LEAGUE:** Play on Mondays and Wednesdays during league play, and possible Tuesdays and Thursdays during tourney play at Lampkin Park and Hobson Grove Softball Fields. May play DH's on given nights.

_____ **MEN'S OPEN II (Recreation) LEAGUE:** Eleven team limit. Play on Mondays and Wednesdays at Lampkin Park and Hobson Grove Softball fields.

_____ **COED I (Competitive) LEAGUE** Play on Tuesdays and Thursdays during league action and possible Mondays and Wednesdays during tourney games at Lampkin and Hobson Park (If needed). 3 HR Limit

_____ **COED II (Recreation) League** Play on Tuesdays and Thursdays during league action and possible Mondays and Wednesdays during tourney games at Lampkin and Hobson Park (If needed). 1 HR Limit

_____ **MEN'S CHURCH** Play on Mondays, Tuesdays and Thursdays at Lampkin Park and Hobson Grove (if needed)
ENTRY FEE FOR ALL LEAGUES: \$400.00 (Up to \$50 will be returned to teams at the conclusion of the season if they have no forfeits).

Entries are accepted first-come-first-serve upon the paid entry fee. The entry fee includes one umpire, scorekeeper, T-shirt awards. 10 regular season games and a Double Elimination Tournament (No Team Trophies). Players that participate in the COED League are allowed to participate in the other leagues. Teams hit their own restricted-flight softballs (ASA approved MSP-44 cores, max 375 comp). Game times are scheduled at 6:05, 7:15, 8:25, (and 9:30 p.m. only if necessary) unless otherwise indicated. The season may begin in late August and end in late October. Games will be played at Lampkin Park and Hobson Grove, depending upon the number of sign-ups. Requests can not be honored for the tournament.

All entries and \$100.00 non-refundable deposit must be received by the Bowling Green Parks & Recreation Department, 225 East Third Ave., by 4:00 p.m. on August 19, 2011. Make checks payable to Bowling Green Parks and Recreation. There will be a mandatory coaches meeting on Thursday, August 25, 5:30 p.m. at the B.G. Parks & Recreation Department, 225 East Third Avenue. Balance of entry fee will be due at coaches meeting. Teams that do not forfeit will receive a \$50 refund at the conclusion of the season.
