



# 2011 COMMUNITY GARDEN PLOT APPLICATION

I hereby apply to use the city garden plot(s) listed below for the current garden season at Kereiakes Park. I understand that this application is good only for the current season and that I must reapply annually. I understand that misuse of the garden and disregard for other gardeners will not be tolerated.

**TERMS OF AGREEMENT:**

1. **The Parks and Recreation Department Shall:**

- a. Plow, disk and mark off gardens.
- b. **Weather permitting** gardens will be ready by March 31.
- c. Mow all gardens that have weed growth of 24 inches or more.
- d. **Not assume any responsibility for theft from gardens.**

2. **The Gardeners Shall:**

- e. Obey all city, state, and federal laws, statutes, ordinances, and policies.
- f. Produce harvested from the gardens may **NOT** be sold on city property. Anyone selling on city property without a permit/license will be subject to fines and/or court costs.
- g. Maintain the garden in good condition.
- h. Notify Parks & Recreation if she/he decides not to use the garden.
- i. Pay registration fee of \$20 each for full plots (30'x60') or \$15 each for small plots (30'x30').  
**Limit: 2 gardens per household (same address)**
- j. Have everything removed from the gardens by November 7<sup>th</sup>. The gardens will be plowed under for the winter.
- k. Do not remove and/or move the stakes.
- l. Be considerate of your neighbor.

**FAILURE TO ADBIDE BY THE PARK REGULATIONS MAY RESULT IN A BAN FOR FUTURE RENTALS.**

Plots will be available for rental beginning **March 1, 2011 AT 8:30 AM on a first come basis**  
**(No prior registrations will be accepted.)**

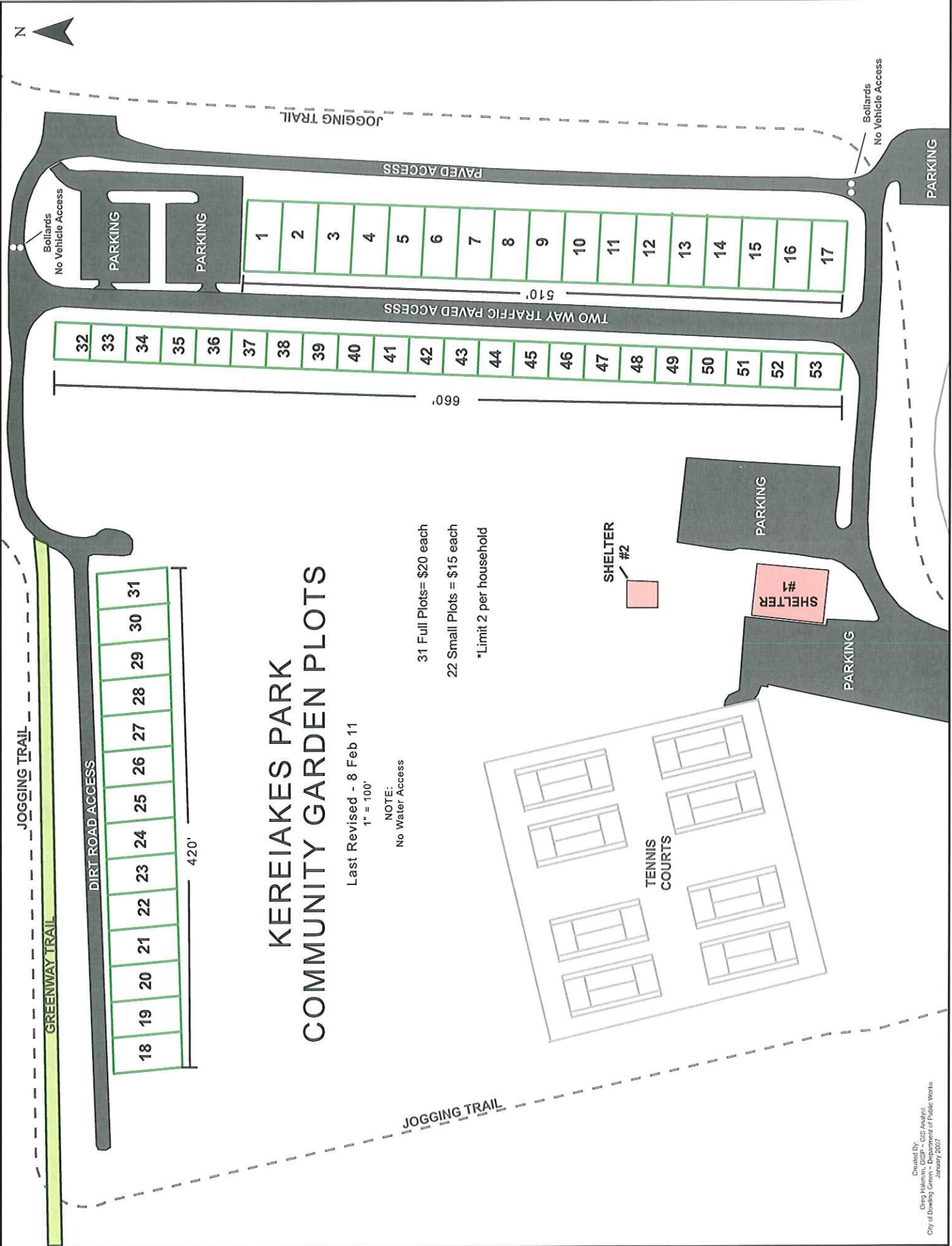
