

CITY OF BOWLING GREEN, KENTUCKY APPLICATION FOR ENTERTAINMENT LICENSE

Under Chapter 18-8 of the City of Bowling Green Code of Ordinances businesses such as hotels, café, restaurants, theaters, clubs or any place which furnish or make provisions for regular or routine entertainment to the public or to its patrons shall pay an annual entertainment license fee of two hundred forty (\$240.00) dollars which shall authorize the activity or entertainers which are contracted to perform. Such entertainers shall include, but not be limited to bands, musicians, disk jockeys, comedians, actors, magicians and other such persons. This annual entertainment license fee shall be for the period of January 1 to December 31. Any new applications for a period less than twelve (12) months shall be prorated at the rate of twenty (\$20.00) dollars per month for the remaining months of the annual entertainment license.

The entertainment license fee shall be in addition to the occupational license registration fee and any net profit fee and shall be payable in advance to the City.
