MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held JULY 16, 2019

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on July 16, 2019. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by the Pastor of First Baptist Church in Richmond, Kentucky and City of Richmond Mayor Robert Blythe, and all present recited the Pledge of Allegiance. Mayor Blythe was recognized as an honored guest and it was explained Mayor Wilkerson and Mayor Blythe are participating in a Kentucky League of Cities Mayor-to-Mayor Program designed to exchange ideas and discuss common interests. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin, Commissioner Dana Beasley-Brown and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

AWARDS AND RECOGNITIONS

Executive Assistant/Public Information Officer Kim Lancaster presented certificates and gift prizes to the winners of the 3rd annual "We are Bowling Green" photo contest: 1st place – WKU Columns by Steven Bailey; 2rd place – A Shanty Sunset by Shawn Jones; 3rd place – Fall in Kentucky by Ella P. Photography; and the people's choice – Backyard Tefiti by Arial Brandon. Ms. Lancaster stated there were over 60 qualified entries in this year's event and many of the photographs will be used by the City in the future, and she thanked all who participated.

Ms. Lancaster also explained the City started an Employee Spotlight Program as an opportunity for City employees to nominate co-workers who go above and beyond, stands out and deserves recognition. She presented the first Bowling Green Employee Spotlight recipient award to Courtenay Howell of the Public Works Department and provided some brief comments about Courtenay and shared the positive comments in her nominations.
