MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held FEBRUARY 4, 2020

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on February 4, 2020. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Commissioner Sue Parrigin and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Dana Beasley-Brown, Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

PUBLIC HEARING

Grants Coordinator Nick Cook conducted a public hearing for the purpose of obtaining citizen views of housing, fair housing and community development needs in Bowling Green, development of proposed activities, and review of past program performance for the Community Development Block Grant (CDBG) Year 17 Annual Action Plan. He reviewed the Annual Action Plan objectives, the process for drafting and approving the Year 17 Plan, and previously funded activities. Mr. Cook explained funds would be used for the Neighborhood Improvements Program (NIP) in the BG Reinvestment Area specifically Census Block Groups 103.3 and 103.4. He reported the City anticipates to receive approximately \$600,000 for Fiscal Year 2021 funding. It was also said written comments were due by February 19, 2020. With no comments from the public during the hearing, the public hearing was closed.

AWARDS AND RECOGNITIONS

City Manager Jeffery B. Meisel announced the City received the Distinguished Budget Presentation Award for the Fiscal Year 2020 budget from the Government Finance Officers Association (GFOA) for the 8th consecutive year. He congratulated the Finance Department staff on receiving this achievement.

Mr. Meisel also recognized Deputy Police Chief Michael Delaney as a 2020 honoree at the Black Achievers Banquet presented by the Martin Luther King Jr. Planning Committee.

City Manager Meisel had no further comments at this time.

ORDINANCE NO. BG2020 – 3 (First Reading) ORDINANCE AMENDING CODE OF ORDINANCES

ORDINANCE AMENDING CHAPTER 2 (ADMINISTRATION), SUBCHAPTER 2-2 (BOARD OF COMMISSIONERS) OF THE CITY OF BOWLING GREEN CODE OF ORDINANCES

Title and summary of Ordinance No. BG2020 - 3 was read by the City Clerk. Motion was made by Nash and seconded by Beasley-Brown for first reading of said Ordinance. As the sponsor of the ordinance, Commissioner Nash explained the first amendment relates to an administrative change pursuant to statute regarding the filing deadline to run for elected office, and the second amendment relates to how the Board of Commissioners vote on the first reading of an ordinance. He further explained State law only requires a vote on the second reading. In addition, he believed the first reading should provide notice to the public and allow for the Board of Commissioners to seek input from citizens. Nash also thought voting on the first reading caused an appearance the Board of Commissioners already made a decision on the topic and were not considering public input. He encouraged allowing time for public input before making a final decision and believed public participation would enhance the quality of the Commissioners action. Commissioner Beasley-Brown stated in her experience citizens were confused on the Board of Commissioners voting on the first reading and she would support the amendment to be more transparent by allowing time between the first reading and second reading to make a decision. Commissioner Parrigin commented on the importance of transparency and citizens knowing a Commissioner's position at first reading. She was in favor of keeping the ordinance language as is and voting on the first and second readings. In addition, there was conversation about introducing more topics at work sessions. Beasley-Brown suggested discussing the topic related to the first reading of ordinances at an upcoming work session. Motion was made by Nash and seconded by Denning to table Ordinance No. BG2020-3 and plan for further discussion at the next regular Board of Commissioners meeting during a work session. With no other discussion, a roll call vote was taken.
