Meisel indicated the activation date would depend on the approval process, and explained the purpose of the ordinance was to establish and designate boundaries for an EDC. There was a question about making amendments to the boundaries or map, and it was said amendments may be made as needed. Meisel said staff would establish regulations and address the concerns from previous work sessions, such as police support, public restrooms, trash and noise. Commissioner Parrigin indicated the Board of Commissioners' were committed at the annual Strategic Goal Planning Work Session to increase employee wages, which included public safety. transparency and hinder participation. Commissioner Hill said she had a hard time asking staff to spend countless hours preparing for work sessions when there was not enough support. Commissioner Parrigin encouraged more communication with each other to coordinate possible work session topics. Mayor Alcott asked for additional discussion, and with none, a roll call vote was taken.

WORK SESSION

Following a brief recess at 6:10 p.m., a work session began at 6:15 p.m. Neighborhood and Community Services Director Brent Childers stated the purpose of the work session was to discuss an ebike partnership with Western Kentucky University (WKU). He reviewed the advantages of the bike share program, which included: increased opportunities for multi-modal transportation and transportation between WKU campus and downtown, reduced vehicle trips between destinations, first and last mile for public transit, reduced transportation costs for users, and attract talent to grow the overall workforce. Additionally, Childers explained how the service would work with the vendor Wheels, and outlined the safety features on the e-bike, as well as the timeline to implement the agreement and plan. A majority of the Board of Commissioners were in agreement with the partnership and it was said a finalized agreement with WKU and Wheels would be developed and tentatively available in the fall semester.

There being no further business to come before the Board of Commissioners, at approximately 6:30 p.m., Mayor Alcott declared this meeting adjourned.
