DeFebbo recounted the creation of the Internal Auditor position and Audit Committee in 2006. Internal Auditor Deborah Jenkins summarized the process of the external auditor and involvement by the Audit Committee to review and approve the annual financial audit. Audit Committee Chair Tony Witty stated the Audit Committee met on November 13, 2017 for a presentation of the CAFR. He reported the City received a clean opinion and the external auditors were very complimentary of City staff. He also stated the Audit Committee recommended approval of the Fiscal Year (FY) 2017 annual audit.

Commissioner Denning commented about the outstanding work performed by the Internal Auditor and Audit Committee members. Commissioner Williams agreed and stated equally impressive was the CAFR document prepared by the Finance Department. Chief Financial Officer Jeff Meisel commended Assistant Chief Financial Officer Erin Ballou for all her work on preparing the CAFR. He also reported FY2017 was a good year for the City with an overall increase in fund balance despite an increase in pension liability, and the City has been able to pay down 37% of its outstanding debt over the past nine years.

Commissioner Denning stated he wants the City to always take care of its retirees and make sure they get what they were entitled to. Mr. Meisel reported the City has made every employer required contribution to the County Employees Retirement System (CERS) through the years and everything else was out of the City's control as a State administered pension program. He acknowledged the City was doing its part and would continue to do so, even looking at a significant increase in CERS employer contribution costs going into FY2019.

Commissioner Nash asked if the audit could be posted online and placed in the list of featured links on the front page of the website for a period of time. Mr. Meisel confirmed the audits are posted on the website and a condensed version, called the Popular Annual Financial Report or PAFR, would also be developed and posted on the website for a "reader's digest" version. Following the discussion, a roll call vote was taken.
