

2018: The Year in Review and a Look Ahead

ROADS AND TRANSPORTATION: BETTER WAYS TO GET AROUND TOWN

- Completed installation of the first phase of directional wayfinding signage in the downtown area with assistance from the Bowling Green Area Convention and Visitors Bureau.
- Drainage improvement projects were completed at South Sunrise Drive, W. 14th Avenue, Woodford Street, Loop Avenue, Nutwood Street, 5th Avenue, and Paddock Way.
- Over 4,500 feet of new sidewalk was constructed on South Sunrise Drive, Hogle Drive and Logan Way.



- Over 1,000 feet of sidewalk was replaced along Nutwood Street.
- The Smallhouse Road Widening Project Phase I construction was completed, creating 3 lanes, new storm sewers, and an eight foot wide multi-use path.
- The Smallhouse Road Widening Project Phase II design was completed.

- Turn lane improvements were made at the intersection of Creason Street and Emmett Drive alleviating traffic issues.
- Concrete intersection rehabilitation was completed at three downtown intersections.

STRONG NEIGHBORHOODS: IMPROVING INFRASTRUCTURE, EMPOWERING PEOPLE

- Exterior rehabilitation was completed on over 100 houses to remove blighting influences and improve curb appeal as part of the Neighborhood Improvements Program.
- Two new Neighborhood Builders Awards were established and awarded: "Model Neighborhoods" designation to the Crestmoor and Hillview Mills Neighborhoods and a "Pillar Award" to the Eloise B. Houchens Center.
- A new kickoff event for the #BGGovToGo was launched with a Star Wars themed Community Block Party featuring "Touch a Truck" and other activities.



• The Over 50 Citizen's Academy was featured in the annual AARP publication, "Where we Live 2018: 100+ Inspiring Examples from America's Local Leaders."

• The scope of the Select Neighborhood Action Program (SNAP) was expanded to include organizational development and organizational triage and troubleshooting to address the changing needs of neighborhoods and the sustainability of organizations.

PUBLIC SAFETY: MORE STAFF, BETTER EQUIPMENT

- Bowling Green Fire Department (BGFD) received a Homeland Security Grant in the amount of \$15,600 for the purchase of urban search and rescue gear.
- Bowling Green Police Department (BGPD) received a \$245,000 grant from the Kentucky 911 Services Board to upgrade the existing 911 system to the Next Generation 911.
- A second set of turnout gear was provided to all BGFD employees to increase safety and assist with a cancer reduction initiative.
- The locker rooms and bathrooms were renovated at BGPD and the roof was replaced.
- BGFD replaced six fire apparatus: one rescue engine, four fire engines, and one aerial truck.
- A total of six 911 dispatchers were hired to provide more efficient services.



- BGPD purchased and deployed Narcon (Naloxone) to treat drug overdose victims and accidental narcotic exposures to officers.
- Ten new BGFD Firefighters were hired and completed the recruit class.
- The BGPD Criminal Investigation Division constructed a "viewing room" to allow private live remote viewings of criminal interviews.
- Seven new BGPD Officers were hired.
- BGFD is converting all gasoline powered hydraulic extrication equipment ("jaws of life") over to battery powered units for increased efficiency.



PARKS AND RECREATION: NEW AND IMPROVED FACILITIES

- The Reservoir Hill Park improvements project was completed resulting in ADA accessible parking and walking paths, replacement of a retaining wall, and installation of a new bus shelter for the public transit system.
- The Lampkin Park walking paths project was completed resulting in 6,000 linear feet of new walking paths connecting park users to amenities within the park and connecting the nearby neighborhood to and through the park.



- Playgrounds were replaced and improved at Lampkin and Covington Woods Parks.
- A shelter was replaced and an additional plaza was constructed at Pedigo Park.
- The gymnasium floor at F.O. Moxley was sanded, repainted and refinished.
- Numerous upgrades were completed at Russell Sims Aquatic Center including a new entry building, expanded bathrooms, and pool bottom renovations.



- Ornamental lighting at RiverWalk Park was replaced.
- A much needed parking lot was added at Kereiakes Park.
- The CrossWinds Pro Shop was renovated, updated, and the square footage was increased.
- A new zip line was opened and work began on the Lime Stone Springs Spray Ground at Lampkin Park.
- Work began on the soccer fields at Preston Miller Park which will include four fields, lights, and an additional parking lot.
- The structural rehabilitation project at the Hobson House at Riverview Park was completed.

WAYS WE'RE SAVING MONEY

- Group term life insurance was bid out, resulting in an employer cost reduction beginning January 2018, with no change in employee cost for additional coverage.
- Staff performed quantitative respirator fit testing with all sworn police officers and golf spray technicians (110 employees). Savings in excess of \$4,000 was achieved by performing this service in-house.
- Staff applied 481,282 gallons of leachate under the City's land farming permit at the Butler County Landfill saving \$36,095.
- Over \$3.2 million in personnel and non-personnel under spending was captured during FY2018 through disciplined fiscal management of the budget, which will be applied to future capital projects and other needs.

BETTER WAYS OF WORKING

- The Human Resources Department hosted a job fair with open interviews for the Parks and Recreation Department, saving time and money by filling multiple positions at one time.
- Over \$121,000 was collected from seven online public auctions of surplus and confiscated items through GovDeals.com.





- The development of the new records management facility was completed, and staff initiated implementation of a records tracking system and began accepting records for long-term storage.
- The City Care Center completed two years of operation in January 2018, and hours of operation were increased in November 2017.



- Physician appointment utilization averaged 83.7% at the City Care Center.
- 133 employees attended a total of 51 WKU instructed employee and supervisor development classes coordinated through Human Resources.
- NCS Housing Division implemented procedures to allow management companies to be considered as Housing Choice Voucher (HCV) landlords, expanding the number of landlords available for the HCV program.
- Public Works co-sponsored and provided staff for two Household Hazardous Waste Disposal Days, creating an opportunity for residents to properly dispose of household hazardous wastes for free.
- During FY2018, the pool of potential bidders for City projects was increased by 14% over the previous year to ensure competition and to achieve the best price and value for purchases greater than \$20,000.

• The building permit plan storage area at 707 East Main was updated to allow for plans to be prepared, printed, scanned, copied, and to be available electronically in the field.

BETTER SECURITY AND SAFETY

• A large number of security cameras were replaced at various locations as part of a two year replacement plan.



- New cameras were added at Weldon Peete, Fountain Square, Lovers Lane Soccer Complex, Lampkin, Preston Miller and H.P. Thomas Parks.
- A new "Online Reporting" tool was launched through BGPD to provide improved and more secure access to police reporting services.

AWARDS, ACCOMPLISHMENTS AND GRANTS

• The City was recertified as a "Drug-Free Workplace" through the Department of Workers' Claims and received a 5% workers' compensation premium savings of \$24,306. The annual premium savings accounts for approximately 75% of the funding needed to perform pre-employment, random and post-accident drug and alcohol testing.

- The City's FY2018 Budget Document received the sixth consecutive Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA).
- Almost \$25,000 was raised during the BGFD "Fill the Boot" Campaign for the Muscular Dystrophy Association.
- BGFD received its third consecutive re-accreditation from the Commission on Fire Accreditation International (CFAI) for meeting the criteria established through the CFAI's voluntary self-assessment and accreditation program.
- The City was awarded the Kentucky League of Cities (KLC) Enterprise Cities Award for the Academy for New Americans Program. The Enterprise Cities Award recognizes outstanding projects and programs in Kentucky cities. The award celebrates cities and allows KLC member cities of all sizes to be inspired by, learn from and replicate successes happening in other Kentucky communities. The KLC award had a \$1,000 prize to be used to enhance the Academy for New Americans.
- BGPD received its sixth consecutive Kentucky Association of Chiefs of Police accreditation.

• The Housing Division received the U.S. Department of Housing and Urban Development (HUD) High Performer Status for the twelfth straight year.



- A safety grant of approximately \$6,000 was awarded from the KLC Insurance Services for 50% reimbursement on certain sidewalk repair and the purchase of Personal Protective Equipment for various departments.
- FY2017 Comprehensive Annual Financial Report (CAFR) received the GFOA award for the twelfth consecutive year.



- FY2017 Popular Annual Financial Report (PAFR) received the GFOA award for the seventh consecutive year.
- Received the GFOA Award for Excellence for exceptionally well implemented best practice for Safeguarding Equipment Assets with Physical Inventory.

FISCAL YEAR (FY)2019 KEY BUDGET **RECOMMENDATIONS**

- Compared to last year's adopted budget, revenues in FY2019 are projected to increase by 4.2% for All Funds and 6.6% for the General Fund.
- The City's FY2019 operating budget, excluding capital projects, reflects an increase of only 2.8% (\$2.6 million) for All Funds and 4.0% (\$2.4 million) for the General Fund compared to FY2018.
- The General Fund operating budget absorbs a cost of living adjustment and merit raise for eligible employees, includes a 12% increase in CERS rates, pre-funds a portion of a future pension unfunded liability payment, and adds 14 new full-time positions; including two police officers and nine firefighters to staff the future Lovers Lane Fire Station.



• No local tax increases were recommended or adopted in the budget for the sixteenth consecutive year, with no impact to fund balance in the General Fund nor any need to issue debt.

- There are no new financed projects proposed in FY2019. The total adopted Capital Improvement Program (CIP), including debt, is approximately \$29.6 million, which is a 0.4% decrease compared to FY2018, and is the second year since FY2008 in which new capital projects represent 60% of the total CIP budget.
- The FY2019 budget continues special funding for workforce development programs through the Bowling Green Area Chamber of Commerce to foment the creation and retention of new jobs and continues to cover half of the annual debt service obligation of the Kentucky Transpark bonds.
- Nearly \$2.6 million of local tax dollars will be used to continue to pay the annual ballpark debt obligation and to distribute incremental growth from the Downtown Tax Increment Financing (TIF) District to support new development.
- Almost \$703,000 of Community Development Block Grant (CDBG) and local tax dollars will be used for the fifth year of the BG Reinvestment Area to make neighborhood improvements within a defined target area. Also, \$40,000 of local tax dollars will be used for the annual SNAP Grant Program to assist neighborhoods with smaller improvement projects.

 \$5.2 million in State and local funds will be used to maintain streets and sidewalks as part of the City's annual overlay and reconstruction program, continue improvements to Smallhouse Road, install a new traffic signal at Dishman Lane/ Industrial Drive, upgrade existing traffic signal switches, enhance Shive Lane and make other localized residential traffic improvements.



- The FY2019 budget includes the second year of funding to begin public improvements in the downtown area later this fall, implementing safer pedestrian access, improving deteriorating public infrastructure, enhancing Morris Alley, and providing an inviting connection between Fountain Square and Circus Square Parks with improvements along Heritage Trail.
- \$1 million in local tax revenues will be used to continue the Stormwater Mitigation Program and the Sidewalk Improvement Program for the enrichment of community livability.

• Over \$5.1 million will be dedicated to enhance public safety services with upgraded facilities/vehicles/equipment, such as the purchase of new safety equipment for BGFD Suppression and scene reconstruction equipment for BGPD, along with the construction of a new fire station on Lovers Lane and a new bulk evidence storage facility for Police.



• Almost \$2.5 million in local tax revenues will be used to upgrade equipment/ vehicles for Parks and Recreation and implement recommendations from the Parks Master Plan, including baseball field lighting upgrades at Kereiakes Park, installation of an outdoor fitness playground at Preston Miller Park, basketball court refurbishment at Parker Bennett, construction of a shelter at the Loops at Lovers Lane, renovations and maintenance of the wall at RiverWalk Park, installation of an inclusive playground and skate park renovations at Roland Bland Park, and adding a Greenways connection under the River Street bridge, as well as designing plans for a public mausoleum at Fairview Cemetery.
