# MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held November 21, 2023

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on November 21, 2023. Mayor Todd Alcott called the meeting to order. Youth Minister T.J. Renfro of First Baptist Church provided the invocation and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Dana Beasley-Brown, Commissioner Melinda Hill, Commissioner Sue Parrigin, Commissioner Carlos Bailey and Mayor Todd Alcott. Absent: none. There was a full quorum of the Board of Commissioners.

### AWARDS AND RECOGNITIONS

City Manager Jeffery B. Meisel recognized Recreation Division Manager Cameron Levis for recently being named President Elect for the Kentucky Recreation and Parks Society (KRPS). Meisel also congratulated the Neighborhood and Community Services Department and Downtown Development Division on receiving ten (10) Traverse Awards from the Kentucky Travel Industry Association for marketing and event building efforts.

#### CITY MANAGER

City Manager Meisel reminded the audience to sign-up in the back of the Commission Chamber in order to speak during public comments.

Meisel introduced Buddy Steen of Central Region Ecosystem for Arts, Technology, and Entrepreneurship (CREATE) to provide an update on the past year's accomplishments. Mr. Steen provided a brief report and stated a survey was sent to regional ecosystem leaders, including City and County governments, Western Kentucky University, and various others. The survey was about the ecosystem's alignment and averaged a 4.2 out of 5, and he planned to continue the survey annually. It was further reported 183 new opportunities and jobs were created, 21 startups created or in the process of being created, \$63 million has been invested in regional companies and anticipated annual City withholdings generated should be between \$120,000 and \$170,000.

MUNICIPAL ORDER APPROVING AN ENERGY SAVINGS CONTRACT WITH TRANE, U.S. INC. OF LOUISVILLE, KENTUCKY IN AN AMOUNT NOT TO EXCEED \$2,772,000 THROUGH OMNIA PARTNERS COOPERATIVE PURCHASING CONTRACT

Summary of Municipal Order No. 2023 – 266 was read by the City Clerk. Motion was made by Beasley-Brown and seconded by Bailey for consideration of said Municipal Order. Meisel reviewed and recommended approval of an emergency savings contract with Trane, U.S. Inc. through Omnia Partners Cooperative Purchasing Contract in an amount not to exceed \$2,772,000. It was said this would be the third energy savings agreement with Trane, and the contract included HVAC replacements and parks lighting, along with other improvement projects, with a guaranteed price savings of \$1,621,378. Following some discussion, a roll call vote was taken.

## MUNICIPAL ORDER NO. 2023 – 267

MUNICIPAL ORDER AUTHORIZING CHANGE ORDER NO. TWO TO THE CONTRACT WITH SCOTT, MURPHY & DANIEL OF BOWLING GREEN, KENTUCKY FOR FIRE STATION #5 AND TRAINING CENTER CONSTRUCTION PROJECT IN THE AMOUNT OF \$900,000, FOR A TOTAL PROJECT COST OF \$17,608,963

Summary of Municipal Order No. 2023 – 267 was read by the City Clerk. Motion was made by Beasley-Brown and seconded by Bailey for consideration of said Municipal Order. recommended approval of Change Order No. Two to the contract with Scott, Murphy & Daniel for Fire Station #5 and Training Center construction project in the amount of \$900,000, for a total project cost of \$17,608,963. He explained the project included a 30,000 square foot building, and said City staff was conservative on the initial cost and the total never included a 10% contingency, which should have been built into the project. The recommendation for a \$900,000 change order would provide the City with the 10% contingency and include the funding needed to add in a specialized sock for each micropile hole to help reduce the amount of cement grout needed. Public Works Director Andy Souza and Scott, Murphy & Daniel Project Manager Mike Walker explained the karst situation on the property in further detail and was confident the change in technique with the sock would allow the process to be successfully completed and construction could start sooner. The total change order to be issued to Scott, Murphy & Daniel would total \$242,309, with the remainder \$657,691 serving as a contingency for any future needs related to the project. Commissioners Hill, Beasley-Brown and Bailey expressed concern and interest in the City Attorney and City staff working together with architectural firm Brandstetter Carroll to cover costs the City incurred due to the architects negligence and/or costs that exceeded the approved amount. Commissioner Hill explained she supported the Police and Fire Departments, however she would be voting no, just as she did on the first change order. Hill would like the City to hold architects and engineers accountable for its actions and believed the residents of Bowling Green should not be responsible for Brandstetter Carroll's mistakes. Commissioners Bailey and Beasley-Brown explained they wanted to see more protections in place to prevent this from happening in the future and was in favor of the change order, contingent upon the City Attorney and staff collaborating with Brandstetter Carroll to pursue any lost costs. Following discussion, Mayor Alcott asked for a roll call vote.
