MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held May 2, 2017

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on May 2, 2017. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Commissioner Rick Williams, and all present recited the Pledge of Allegiance. Assistant City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin, Commissioner Rick Williams and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

AWARDS & RECOGNITIONS

Mayor Wilkerson presented a handmade sculpture made by the 2nd Brigade Combat Team which was presented to him and Commissioner Parrigin at an event with the 101st Airborne Division of Fort Campbell. Schaller-Ward reviewed the need for rehabilitation to Fountain Square Park and recommended the bid award. She described the project to include structural repairs to the fountain, painting light fixtures, replacement of brick pavers and broken curbing. It was further mentioned there was one bid received and it came in under budget, and the project is scheduled to begin in July and be completed in Commissioner Denning provided some history regarding Fountain Square Park and explained there would be a third generation Murphy family member working on this project. He further expressed his confidence the project would be completed based on the bid specifications and above. Commissioner Nash asked about replacement of missing pavers outside the park. Schaller-Ward replied that staff could temporarily repair the pavers until a permanent solution was determined, however this bid did not include pavers outside Fountain Square Park. To clarify some questions, Neighborhood and Community Services Director Brent Childers reiterated the specifications for Scott & Murphy, Inc. includes repairs inside Fountain Square Park, however a Request for Qualifications (RFQ) for an Engineering Design Firm to assist with overall downtown improvements would be planned in the near future. After the discussion, a roll call vote was taken.
