ORDINANCE AMENDING CHAPTER 2
(ADMINISTRATION) OF THE CITY OF BOWLING
GREEN CODE OF ORDINANCES TO REVISE THE
MEMBERSHIP OF THE GREENWAYS
COMMISSION OF BOWLING GREEN AND
WARREN COUNTY AND TO MAKE OTHER
ADMINISTRATIVE AMENDMENTS

WHEREAS, the City of Bowling Green and Warren County created the Greenways Commission of Bowling Green and Warren County; and,

WHEREAS, the membership of the Commission currently includes one member from the City's Board of Commissioners; and,

WHEREAS, the Board of Commissioners has determined that it is in its best interest to eliminate the appointment of an elected City official; and,

WHEREAS, a review of Chapter 2 also indicated that two of the referenced code provisions that were appealable to the Administrative Appeals Board were no longer applicable and need to be removed.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

1. Chapter 2 (Administration) is hereby amended as follows:

. . .

- 2-21 ADMINISTRATIVE APPEALS BOARD
- 2-21.01 Created.

There is hereby established the Administrative Appeals Board. The Board shall have such duties as assigned to it by ordinance, and shall hear appeals from the following decisions of:

- a. The City Manager regarding alarm permits (Chapter 15 9);
- b. The Board of Electrical Examiners (Chapter 10);

- eb. The City Manager and/or Board of Commissioners regarding personnel appeals and grievances (Chapter 17); and,
- dc. Any other matters referred to it for review by ordinance or municipal order. The Chief Financial Officer regarding business licenses (Chapter 18).

- 2-22 GREENWAYS COMMISSION OF BOWLING GREEN AND WARREN COUNTY.
 - 2-22.01 Created.

The Greenways Commission of Bowling Green and Warren County is hereby created.

- 2-22.02 Membership, Terms, Vacancies.
- a. The Greenways Commission of Bowling Green and Warren County shall consist of twelve (12) members, with each serving a term of three (3) years, or by the term of office held. Members may be reappointed for successive terms. Vacancies shall be filled within sixty (60) days by the appropriate appointing authority as indicated hereinbelow; otherwise the Greenways Commission shall fill the position for the remainder of that term. The members shall be appointed in the following manner:
- 1. one (1) member from the City of Bowling Green Board of Commissioners to be appointed by the Mayor, with the approval of the Board of Commissioners;
- 21. one (1) member from the Warren County Fiscal Court to be appointed by the County Judge Executive, with the approval of Fiscal Court;
- 32. six (6) five (5) members appointed by the Mayor, with approval by the Board of Commissioners; and,
- $4\underline{3}$. five (5) members appointed by the County Judge Executive, with approval by the Fiscal Court.

b. The Greenways Commission shall also be composed of a representative of the

City Parks and Recreation Department, a representative of the County Parks and Recreation

Department, a representative of the City-County Planning Commission, the Operation P.R.I.D.E.

Executive Director and the Downtown Redevelopment Authority Executive Director, who shall act as

nonvoting ex-officio members.

c. The Greenways Coordinator shall be a nonvoting member of the Greenways

Commission and shall be present at all of its meetings.

2. The provisions of this Ordinance are hereby declared to be severable, and if any section,

phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not

affect the validity of the remainder of this Ordinance.

3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in

conflict herewith are hereby repealed.

4. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on

June 7, 2011, and given final reading on June 21, 2011,

and said Ordinance shall be in full force and effect upon signature, recordation and publication in

summary pursuant to KRS Chapter 424.
