Commissioner Beasley-Brown expressed she wanted to work together toward a shared goal to hold public officials to the highest ethical standard, while also being a good steward of taxpayer's dollars. She added excessive fines were considered unconstitutional. Commissioner Parrigin stated she hoped in January 2021 the Board of Commissioners would reconsider approving the recommended legal fees as proposed by the Board of Ethics. Following a statement the Board of Ethics could be weaponized, Commissioner Parrigin believed there was an attempt because of the recent complaints filed against her and others, which were determined to be frivolous and unfounded. Commissioner Denning expressed continued concern with what the accused violator would be required to pay. Commissioner Nash added he believed it was an undesirable consequence to ask individuals to pay City's legal fees. Mayor Wilkerson explained he respected the Board of Ethics opinions and after receiving feedback from citizens, he agreed with the initial recommendation. Once further discussion concluded, a roll call vote was taken.
