The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on January 4, 2022. Mayor Todd Alcott called the meeting to order. An invocation was provided by Crossland Community Church Senior Pastor Greg Farrell and all present recited the Pledge of Allegiance. However, she noted it was not a scam or politically affiliated. Commissioner Parrigin shared she did not have access to a digital database of phone numbers. Commissioner Bailey made some remarks and said the text message was a tool to reach out to victims of the storm.
