The Fall 2025 Leaf Season commenced on November 17, with crews beginning the collection of leaf piles in Zone 1. This year, the team is implementing a streamlined approach across all ten zones to optimize leaf collection and reduce overhead costs. Zones 1 through 3 were collected in November, with the remaining zones scheduled for collection in December.

**2025 Quick Build Project** - The City of Bowling Green was selected by the Kentucky Transportation Cabinet (KYTC) as one of three cities to participate in Smart Growth America's 2025 Complete Streets Leadership Academy - a national program that helps cities create safer, more connected streets. We received a \$22,000 grant supporting a quick build demonstration project on state roadways within the City. (Selections below) This was a hands-on way to show Bowling Green is committed to safety, innovation and community-driven solutions. We're especially proud to be working closely with KYTC on this effort, strengthening local and state partnerships that can lead to long-term change.

City Engineer Kyle Hunt worked with the Kentucky Transportation Cabinet and Metropolitan Planning Organization to improve safety for pedestrians and cyclists in high-traffic areas, specifically at Morgantown Road and the Smallhouse Road/Covington Street intersection with Scottsville Road. The Operations team and KYTC road crews supported these measures.




#### **FY 2026 Pavement Evaluation**




(Top) Every year, the city engages an independent firm to evaluate the condition of its roadways. This year, Cyclomedia, a company specializing in street-level imagery and LiDAR data, has been contracted to create a 3D digital twin of the area for analysis and assessment. Inset-City Engineer Melissa Cansler and Construction Coordinator II Melanie Shy had the opportunity to tour the vehicle during its inaugural visit to Bowling Green on November 24.

(Bottom) The 2026 Street paving list (also known as overlay) is depicted below. This year, about 12 miles of roadway will be milled and replaced as part of the overall street maintenance program. Yearly assessments, like the one depicted above from Cyclomedia, help the staff determine the sections in most need of repair or replacement. (About 94 segments will be part of the overlay)





Stormwater Planning



Civil Engineer Trevor Cline collaborated with Environmental Manager Matt Powell to design an expanded stormwater basin situated between the 200 Block of Turkey Run Drive and the CSX Rail Line. In April 2025, following heavy rainfall, the original basin became surcharged, resulting in flooding affecting multiple residences along Turkey Run Drive and Red Clover Avenue.

Public Works has since completed a comprehensive survey and design plan to retrofit the basin, thereby enhancing its storage capacity. The city coordinated with the Warren County Water District and Infinity Pipeline Inc. to ensure the work would not interfere with a concurrent sewer project in the vicinity. The total cost for this undertaking amounts to \$198,800, and the Board of Commissioners granted approval for the project on November 18.





(Left) The Butler County Landfill Utility project commenced this month. The underground electrical systems have encountered repeated failures and are currently being replaced with overhead lines. This initiative will be reimbursed by the Kentucky Division of Waste Management and is anticipated to be completed successfully over the next few months.

(Below) A revised ordinance establishing the Bowling Green Stormwater Utility was presented by Environmental Manager Matt Powell and passed by majority vote during the Board of Commissioners meeting on November 4th, and the second reading passed on November 18th. This approval represents the first step in a significant, multi-phase initiative. The first phase is the immediate establishment of a Fee In Lieu of Construction (FILOC) program for post-construction stormwater quality management on new development. The second phase is the implementation of the stormwater utility in January of 2027. This represents a major step forward for funding stormwater infrastructure improvements in Bowling Green.











The annual Erosion Prevention and Sediment Control event at Glen Lily Landfill educated over 130 participants on effective techniques and best practices in an outdoor classroom enviornment (6 November).






