# MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held August 19, 2025

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on August 19, 2025. Mayor Todd Alcott called the meeting to order. Commissioner Carlos Bailey provided the invocation and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Carlos Bailey, Commissioner Dana Beasley-Brown, Commissioner Melinda Hill, Commissioner Sue Parrigin and Mayor Todd Alcott. Absent: none. There was a full quorum of the Board of Commissioners.

#### PUBLIC HEARING

Assistant City Manager/Chief Financial Officer Katie Schaller-Ward conducted a public hearing for the purpose of obtaining comments from residents regarding the proposed 2025 property tax rates. She reported total real estate property growth was 7.6%, with existing property growing by 6.3% and new property growth at 1.3%. Ms. Schaller-Ward explained it was a requirement to hold a public hearing when the rate is set between the compensating rate and a rate with a 4% increase. She recommended the 2025 real property tax rate remain the same as the previous year at \$0.204 and personal property tax rate at \$0.204. There was some history of the new, existing and total growth rates of real property values provided, as well as comparisons of revenue calculations for Fiscal Year 2025, and the average Kentucky tax rates. The property taxes are due December 31, 2025, with a 10% penalty to be applied beginning on January 1, 2025. Since it was a public hearing, Schaller-Ward inquired if anyone from the public wished to speak on the issue. The Board of Commissioners explained the property tax increases residents may be seeing was due to property reassessments over the last year from the Warren County Property Valuation Administrator (PVA), and assessments were not determined by the City. With no further comments, the public hearing was closed.

#### AWARDS AND RECOGNITIONS

City Manager Jeffery B. Meisel recognized the Public Works Department as the Kentucky American Public Works Association (APWA) Chapter made history by earning the Presidential Acknowledgement of Chapter Excellence Award from the APWA for the very first time. He acknowledged Ryan Johnson, Public Works Department Operations Division Manager and Kentucky APWA Vice President, and Derrick Sanders, Crew Leader and Vice Chairman of the Southern Branch of Kentucky APWA.

#### CITY MANAGER

Meisel reminded the audience to sign-up in the back of the Commission Chamber in order to speak during public comments.

Tim Allen of SOKY Patriots, a non-profit organization, comprised of veterans and patriots working together to improve the lives of our veterans, Patriots, and civilians living with disabilities. He discussed the memorial garden and opportunities for sponsorship.
