The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on March 19, 2019. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Commissioner Brian "Slim" Nash, and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Dana Beasley-Brown and Mayor Bruce Wilkerson. Absent: Commissioner Sue Parrigin. There was a quorum of the Board of Commissioners.

Mayor Wilkerson expressed sympathy to Commissioner Sue Parrigin and family due to the passing of her father.

AWARDS & RECOGNITIONS

Mayor Wilkerson introduced Amy Cardwell, Sports Sales Director of the Convention and Visitors Bureau, and she recognized Eric Ward with the Mid-South Conference. Mr. Ward provided updates on the Mid-South Conference events and explained there are approximately eighteen (18) events scheduled in the Bowling Green area which are expected to generate about 6,000 hotel room stays. He also mentioned there are a total of 33 member schools in the Mid-South Conference.

Title and summary of Ordinance No. BG2019 – 6 was read by the City Clerk. Motion was made by Denning and seconded by Nash for first reading of said Ordinance. At the request of the City Manager, City Attorney Gene Harmon explained the City has been negotiating with North Central Telephone Cooperative to provide telecommunications services such as internet and telephone within the City. He confirmed this does not include cable, and based on Kentucky law, the City must approve the creation of a franchise by ordinance, advertise for a non-exclusive bid, and later award the franchise agreement by ordinance. Mr. Harmon added this ordinance sets out the conditions for the use of public rights-of-way. Following a question from Commissioner Beasley-Brown, Mr. Harmon confirmed there could be more than one (1) company awarded the bid and telecommunications service has the ability to choose where it services in the City. Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.

responsible party for cleaning up the park, and Mr. Harmon confirmed the applicant of the special event is responsible for maintaining Riverfront Park, and it was said in the agreement White Squirrel Brewery is also responsible for the maintenance of the area in which beer is sold and taking necessary action to keep the park free from litter. Title and summary of Ordinance No. BG2019 - 10 was read by the City Clerk. Motion was made by Denning and seconded by Nash for first reading of said Ordinance. In response to a question from Commissioner Beasley-Brown, City-County Planning Commission Executive Director Ben Peterson explained the tract does contain a private ingress/egress easement shared by the lots, however following development it is intended to be accepted as a public street. Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.

ORDINANCE REZONING TRACTS OF LAND CONTAINING 39.11 ACRES FROM AG (AGRICULTURE), RM-3 (MULTI-FAMILY RESIDENTIAL), HB(HIGHWAY **BUSINESS**) (FLOODPLAIN) TO RM-4 (MULTI-FAMILY RESIDENTIAL), HB (HIGHWAY BUSINESS) AND F (FLOODPLAIN) LOCATED AT 0 VETERANS MEMORIAL AND 2337 RUSSELLVILLE ROAD, PRESENTLY OWNED BY KEYSTONE DEVELOPMENT GROUP, LLC C/O MATTHEW TABOR

Title and summary of Ordinance No. BG2019 - 11 was read by the City Clerk. Motion was made by Denning and seconded by Nash for first reading of said Ordinance. Mayor Wilkerson explained this is a recommendation approved by a vote of 5 to 4, with the City appointees in a split vote of 2 to 2. Keystone Development Group, LLC Attorney Chris Davenport stated the rezoning was initially brought before the Planning Commission where it was tabled due to some uniformity.

Once the uniformity was addressed and a number of development plan conditions were added, the Planning Commission approved the rezoning and FLUM change as it is compliant. In response to a question from Commissioner Denning, Mr. Davenport confirmed a signal warrant study was performed by the Kentucky Transportation Cabinet and the results indicated a need for a traffic signal A planned connection to the adjoining neighborhood was discussed and Mr. Davenport said reports showed the connecting neighborhood will utilize the connector more than the new development. Commissioner Nash asked about a buffer that will be used, and it was stated the developer has obligated to include a buffer width within 10 feet of the property line, and to maintain the trees with a caliber of 12 inches or higher. City-County Planning Commission Executive Director Ben Peterson confirmed the FLUM was amended based on the following criteria: the proposed use is clearly compatible with existing surrounding development as demonstrated by the applicant. response to a question, Mr. Peterson indicated the development plans are for a 24 unit, three (3) story multi-family structures, four (4) to eight (8) unit two (2) story structures, as well as commercial development. There was further discussion about a buffer between single family and multi-family residential which requires a minimum of a 25 foot distance between the property line and any structure, and additionally a landscaping buffer such as the combination of deciduous and evergreen trees and/or a fence. Also, connectivity and neighborhood preservation was mentioned, and the City-County Planning Commission considers the connectivity in this development to better accommodate adjoining properties. Commissioner Nash expressed concern related to the volume and speed of traffic in neighborhoods and requested traffic abatement, specifically ways to reduce speed, in Commissioner Beasley-Brown concurred with Commissioner Nash's Springhill Subdivision. comments, and suggested the City commits to traffic calming, safety and balance between new development and neighborhood preservation. Public Works Director Greg Meredith made remarks about the possibilities for traffic calming options. Commissioner Nash requested City staff to provide traffic calming options, such as adjusting the width of the roadway or adding some striping, on future developments which connect to neighborhoods. In response to questions, Mr. Davenport confirmed there is a 100 year flood zone on the property, however, the development must be out of the floodplain before a building permit can be issued. In addition, Mr. Davenport explained there may be some balconies, as they are not prohibited, and Commissioner Beasley-Brown expressed concern of the privacy of the adjoining property owners having a three story building with balconies close. Mr. Peterson answered an additional question and stated wetland areas typically end up being improved following development, as the developer is not allowed to adversely affect the area. Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.

WORK SESSION

Following a brief recess at 5:45 p.m., at approximately 6:00 p.m., a Work Session was held to discuss the future of RiverView Golf Course, and no action was taken. The City Manager provided an overview of the Hobson Grove Golf Course, now known as RiverView Golf Course, and explained the City recently issued a Request for Proposals (RFP) to gauge interest from outside parties to take over the property at RiverView Golf Course. One (1) proposal was received for a 36-hole disc golf course and the Board of Commissioners agreed at its recent Strategic Goal Planning Session to reject the bid, as it was not in the best interest of the City. Mr. Meisel said staff is currently involved in negotiations after sealed bidding with the company that submitted the proposal to discuss the possibility of a partnership to assist with management and staffing. Mr. Meisel explained the course

has been struggling for some time, and believes with improvements to the course local high schools may utilize the course for practices and matches. He also reported the 9-hole golf course is 50 years old with no improvements to the greens or irrigation system, and it was proposed to add a new feature such as a driving range, alongside a renovated course. Parks/Golf Maintenance Superintendent Mike Mitchum reviewed the history of the course, rounds played, which have stayed above 10,000, and the revenues have stayed at least \$150,000 and more, within the years of 1991-2019. Mr. Mitchum said data shows there is potential for a driving range to produce about \$150,000 - \$200,000 annually. He further reviewed the proposed area for the driving range and estimates show the driving range requires nets and poles, equipment and supplies, and tee box construction for a total of \$475,000. Also, the estimate considers the utilization of City staff for some of the construction. Mr. Mitchum discussed the difference in cost between 60 foot and 100 foot nets and poles. It was also reported the 9-hole course renovation is estimated to cost approximately \$250,000 versus modifying the course to a Par 3 which is estimated to cost about \$348,000. There was mention of the possibility to apply for a conservation grant to assist with golf course improvements, and utilization of the Bowling Green Municipal Utilities recycled water for the irrigation system. Bowling Green High School Golf Coach Adam Whitt, Indian Hills Country Club Golf Superintendent Bob McLean, Tony Whitmer, Greenwood High School Golf Coach Mike Newton and Jay Yates spoke in support of renovating the Mr. McLean suggested the use of a professional golf course architect and further research before spending money on improvements. Mr. Meisel confirmed there is \$739,000 available to cover the costs in the current fiscal year. In the absence of Commissioner Parrigin, Mayor Wilkerson stated she expressed interest in continuing golf services at RiverView. discussions, there was a consensus to renovate the 9-hole golf course at RiverView and construct a driving range.

PUBLIC COMMENTS

Mayor Wilkerson opened the floor for any public comments about items not included on the agenda. Eileen Starr spoke in support of a fairness ordinance.

ADJOURNMENT

Mayor Wilkerson indicated the April 2nd Board of Commissioners meeting is canceled and the next regular meeting is April 16th.

There being no further business to come before the Board of Commissioners, at approximately 7:30 p.m., Mayor Wilkerson declared this meeting adjourned.
