

**MINUTES of REGULAR MEETING
of the BOARD of COMMISSIONERS
of the CITY of BOWLING GREEN, KENTUCKY
held July 18, 2023**

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on July 18, 2023. Mayor Todd Alcott called the meeting to order and Commissioner Carlos Bailey provided the invocation. All present recited the Pledge of Allegiance. Title and summary of Ordinance No. BG2023 – 14 was read by the Assistant City Clerk. Motion was made by Hill and seconded by Parrigin for the first and non-binding reading of said Ordinance. Mayor Alcott explained this item had been tabled at the previous Board of Commissioners meeting. He further explained only those who spoke at the previous Board of Commissioners meeting and City-County Planning Commission public hearing may speak during the comment period. Digs on the River, LLC Attorney Chris Davenport stated 1940 River Street had been included in the application in error within the rezoning. Furthermore, he presented an additional condition of development presented to the Planning Commission which would state any tenant compliant with all current lease terms should not be

displaced prior to July 31, 2024 and without 90 days' notice. He briefly stated the rezoning was a unanimous recommendation by the City-County Planning Commission and reviewed the current zoning of the property. Following questions, City-County Planning Commission Executive Director Ben Peterson reviewed the proposed scope of the project and what would be allowed under the current General Business, Highway Business and Light Industrial zoning, as well as infrastructure that would be improved with the development. City Attorney Hillary Hightower advised the proposed zoning complied with the Comprehensive Plan and in order for the Board of Commissioners to reject the recommendation, the record would have to contain facts to support a finding in which the request did not comply with the Comprehensive Plan. Rebecca Voiles, Keila Colorado and Hannah Morse residents of Kentucky Gardens Mobile Home Park located at 1798 River Street spoke in opposition of the rezoning and provided an update on the search for affordable housing. Following statements from Mayor Alcott, Commissioners Beasley-Brown and Bailey, a roll call vote was taken.
