## MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held May 7, 2024

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on May 7, 2024. Mayor Todd Alcott called the meeting to order. Associate Minister Kenneth Hardaway of Lively Stone Church South provided the invocation and all present recited the Pledge of Allegiance.
