## MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held November 7, 2023

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on November 7, 2023. Mayor Todd Alcott called the meeting to order. First Baptist Church Executive Pastor David Tooley provided the invocation and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Carlos Bailey, Commissioner Dana Beasley-Brown, Commissioner Melinda Hill, Commissioner Sue Parrigin and Mayor Todd Alcott. Absent: none. There was a full quorum of the Board of Commissioners.

#### **AWARDS AND RECOGNITIONS**

Police Chief Michael Delaney presented Officer Matt Davis with the Silver Cross as a result of being injured while on duty. The Silver Cross is awarded to members of the department who have been wounded or given their life in the line of duty as a result of a hostile encounter.

#### CITY MANAGER

City Manager Jeffery B. Meisel reminded the audience to sign-up in the back of the Commission Chamber in order to speak during public comments.

Meisel requested a closed session for the purpose of discussions of proposed litigation against or on behalf of the City. Motion was made by Parrigin and seconded by Hill to convene in closed session following the regular meeting pursuant to KRS 61.810 (1) (c). Mayor Alcott called for a roll call vote.

Motion to convene in closed session pursuant to KRS 61.810 (1) (c) was approved by unanimous vote.

Meisel introduced Captain Johnny Horton of the Salvation Army to provide an update on the LifeNav Collaborative Center. He reviewed the proposed design and amenities that would be offered at the center, and explained the project was bid and construction should begin soon. Mayor Alcott recommended continued updates from Salvation Army on the progress and results. There was concern about the construction delay, and Mr. Horton explained it was due to the final design and bid processes, as well as the remediation of asbestos. He confirmed Scott, Murphy & Daniel were the chosen contractor and they were ready to begin. It was reported Lifeskills and Room in the Inn committed to partnering with Salvation Army, and HOTEL INC. wished to wait until the project was completed before investing in the partnership.

#### PUBLIC HEARING

Assistant City Engineer Kyle Hunt conducted a public hearing for the purpose of reviewing the proposed Fiscal Year 2024 expenditure recommendations for the Municipal Aid Program (Liquid Fuel Tax) funds and Coal Mineral Severance Tax funds. He reported the current Liquid Fuel Tax (LFT) fund balance made up unencumbered funds from the previous fiscal year was \$854,000. The Fiscal Year 2024 LFT projected revenues were estimated at \$2,426,000 and projected expenditures were to total

\$2,200,000. Mr. Hunt further explained the projects proposed include street resurfacing of approximately 13 miles of paving on City streets, as well as sidewalk, curb and gutter rehabilitation and other various transportation and intersection spot improvements. In addition it was reported the unencumbered Coal Mineral Severance Tax fund balance was \$178,000, which included carryover funds from the previous fiscal year. The projected revenues would be approximately \$35,000, while expenditures were \$135,000, with a projected ending balance of \$78,000. With no comments or questions from the public, the public hearing was closed.

Meisel recognized the Finance Department for the preparation of the Annual Comprehensive Financial Report, as well as the Audit Committee for its approval and recommendation. Audit Committee Chair Pamela Napier reported MCM CPAs & Advisors had given an unmodified and clean opinion, with no material weaknesses or deficiencies, and the financial report fairly represented the City's financial position. Additionally, she stated the overall net position increased to \$265.5 million, or 13%, over \$234 million reported last year, primarily due to the purchase of capital assets and the reduction of liabilities. Also, the governmental fund balance was \$156.5 million, an increase of \$4.8 million from last year, and the General Fund balance increased by \$3.1 million to \$40.4 million. It was noted the General Fund balance included \$21.5 million in reserve funding. Mayor Alcott asked for additional discussion, and with none, a roll call vote was taken.
