# MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held AUGUST 7, 2018

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on August 7, 2018. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Commissioner Rick Williams, and all present recited the Pledge of Allegiance. Assistant City Manager/City Clerk Katie Schaller-Ward called the roll, and the following members were present: Commissioner Rick Williams, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin and Mayor Bruce Wilkerson. Absent: Commissioner Joe W. Denning. There was a quorum of the Board of Commissioners.

#### **AWARDS & RECOGNITIONS**

Assistant Police Chief Matt Edwards announced the Police Department, with a total of 171 standards reviewed, recently received its fifth consecutive re-accreditation from the Kentucky Association of Chiefs of Police. The Police Department received its first accreditation in 1993 and was the second in the Commonwealth of Kentucky to achieve this distinction. The reaccreditation process occurs about every five years and BGPD remains one of only a few agencies in the State to have maintained its accreditation. Mayor Wilkerson mentioned the City was one of only a few nationwide to have, not only its Police Department, but also Fire Department, Public Works Department and Police Communications Center also accredited.

Commissioner Nash informed everyone he was suffering from a health issue which required him to wear an eye patch and impacted the clarity of his speech. He expressed his appreciation for the understanding and support received during this time.
