MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held SEPTEMBER 20, 2016

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on September 20, 2016. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Fire Chaplain Kevin Lashley, and all present recited the Pledge of Allegiance. Assistant City Manager/City Clerk Katie Schaller-Ward called the roll, and the following members were present: Commissioner Rick Williams, Commissioner Joe W. Denning, Commissioner Melinda M. Hill, Commissioner Sue Parrigin and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

PUBLIC HEARING

Chief Financial Officer Jeff Meisel conducted a public hearing for the purpose of obtaining comments from citizens regarding the proposed 2016 property tax rates. He recommended keeping the 2016 property tax rates the same as 2015, and which have remained the same since 2008 at \$0.206 for real estate and \$0.260 for personal property. Mr. Meisel explained the requirement to hold a public hearing since the recommended rate, albeit unchanged, was slightly higher than the calculated compensating rate of \$0.201. He reported total property growth was 4.9%, with existing property growing by 2.6% and new property growth at 2.3%. He also said property tax bills would be mailed once the tax rates are approved and payment would be due December 31, 2016 with a 10% penalty to be applied if not paid by that date. There were no comments from the public during the hearing.

DISCUSSION OF GO bg TRANSIT PROPOSAL TO EXPAND ROUTES

Mr. DeFebbo explained a request for additional funding was made by Community Action over a year ago to expand the transit routes, after which a study was done to identify the ideal route to meet the needs of the community. He indicated a proposal was received for \$80,000 to expand GO bg Transit to create a fixed route between Greenwood Mall and Mount Victor Olde Town development off Lovers Lane, which includes Life Skills and a variety of medical services as well as the future home of the Cabinet for Health and Family Services.

Community Action of Southern Kentucky Executive Director Melissa Weaver and Transportation Manager Donna Tooley responded to questions about the operating costs and the request for an additional \$25,000 a year for the next five years for a future bus replacement. Commissioner Denning asked for clarification about the extra cost for the additional bus. Ms. Weaver indicated Community Action was applying for grants and seeking other funds to help cover the decline in federal transit funds. She indicated the study showed the cost to operate this new route would be \$300,000; however, by partnering with the City and with making other changes such as limiting the service to nine round trips per day, they have been able to bring that cost down to just \$80,000, which primarily covers the cost of salaries. Ms. Tooley described all the revenue sources and operating budget of the transit system and requirements for operating a fixed route. She also confirmed Community Action was only requesting \$80,000 for this year, but may need to request the additional \$25,000 in future years. She reported they were able to come up with the extra \$25,000 for this year through other sources. Jennifer Tougas, Director of Parking and Transportation Services at Western Kentucky University (WKU), provided a comparison of the WKU transit operating costs (\$75 per hour) to those of GO bg Transit (\$64 per hour) and said GO bg was doing a great job keeping costs down.

Mayor Wilkerson said he would like to see ridership numbers for this new route after the first year to determine its viability. Commissioner Hill expressed a concern that the transit study may not be accurate since she knew of some businesses which were not asked to participate in the survey. She agreed this new route was needed and also felt there could be other routes that these businesses would be willing to partner with GO bg to receive. Ms. Tooley agreed to follow up with those businesses and to provide the ridership numbers.

Following the discussion, City Attorney Gene Harmon clarified a Municipal Order would be ready for the next meeting to amend the FY2017 Appropriation Agreement for Community Action Public Transit to authorize the distribution of the \$80,000.

CLOSED SESSION

Following a brief recess to clear the Commission Chamber, the Board of Commissioners met at approximately 6:05 p.m. in closed session pursuant to KRS 61.810 (1) (c) as previously approved. Mayor Wilkerson confirmed that there may be action required following the discussion.

RECONVENE IN OPEN SESSION

Once all discussion concluded in closed session, the Board of Commissioners reconvened in open session at approximately 6:55 p.m. to consider action. Motion was made by Hill and seconded by Williams to remove Municipal Order No. 2016 - 201 from the table for consideration at this time. With no discussion, a roll call vote was taken.
