MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held AUGUST 15, 2017

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on August 15, 2017. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Mayor Wilkerson, and all present recited the Pledge of Allegiance. Assistant City Manager/City Clerk Katie Schaller-Ward called the roll, and the following members were present: Commissioner Rick Williams, Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

AWARDS & RECOGNITIONS

City Manager Kevin DeFebbo announced the Parks and Recreation Department was named FY2017 Safe Department of the Year by Safety/Risk Manager David Weisbrodt for having 1) zero lost days due to injury, 2) zero dollars spent on general liability claims, 3) a preventable injury frequency rate drop of 47% over the prior five-year average to 3.5 per 100 full-time employee equivalents (FTE), and 4) only 2 minor vehicle collisions. He reported this was all accomplished with more than 55 full-time and 254 part-time employees working 225,000 hours and driving 219,475 miles. Mr. Weisbrodt presented an award to Parks and Recreation Director Brent Belcher for this achievement.

Commissioner Nash encouraged the public to attend an upcoming Civility Training Workshop on August 26, 2017 to be held at the Presbyterian Church of Bowling Green. He said he planned to attend the workshop which will explore what civility is and why it is important.

PUBLIC HEARING

City Engineer Melissa Cansler conducted a public hearing for the purpose of reviewing the proposed use of Municipal Aid Program (Liquid Fuel Tax) funds, and Coal Severance and Processing Tax and Mineral Severance Tax funds for Fiscal Year 2018. She reported the Fiscal Year 2018 Liquid Fuel Tax (LFT) unencumbered balance was \$1,558,562 and projected revenues were \$2,779,000, of which \$1,350,000 was coming directly from the General Fund, with proposed She reviewed the projects proposed for Street Resurfacing expenditures totaling \$2,450,000. (overlay) of approximately 22.5 miles in the total amount of \$2,350,000 and 1,480 feet of sidewalk, curb and gutter repair in the amount of \$100,000. The total projected ending balance was designated to be \$1,887,562. Ms. Cansler also reported the Fiscal Year 2018 Coal-Mineral Severance Tax projected revenues were \$30,000, with an opening balance of \$74,864. She explained there were no specific projects to apply the Coal-Mineral Severance funds in Fiscal Year 2018; however, she identified these funds could be used for transportation safety related issues or the purchase of additional deicer should the need arise later in the year. The projected ending fund balance was \$104,864 for Coal-Mineral Severance. After responding to questions from the Board about the proposed list for street paving and making it available on the City's website, the public hearing was closed since no other public comments were presented.

CITY MANAGER

City Manager Kevin D. DeFebbo requested the addition of a late-filed Municipal Order for consideration by the Board. Motion was made by Wilkerson and seconded by Parrigin to add Municipal Order No. 2017 – 161 to the end of the agenda for consideration. First reading of Ordinance No. BG2017 - 43 was approved by unanimous vote.

Prior to the introduction of the next item on the agenda, Mayor Wilkerson explained he sponsored Ordinance No. BG2017 – 44 for this agenda which would approve the rezoning by rejecting the recommendation of the City-County Planning Commission. He said that although the Planning Commission denied the recommendation for approval (as represented in Ordinance No. BG2017 – 45) it took several votes to obtain this outcome, and based on his protocol an approval of a rezoning should be considered before a denial. Mayor Wilkerson outlined the process to be followed if a recommendation of the Planning Commission was not to be approved. He said the Board of Commissioners would base its decision on the record of the Planning Commission's public hearing and no new testimony could be introduced. He would allow each side time to summarize its position starting with the requestor or zoning applicant.

Title and summary of Ordinance No. BG2017 - 44 was read by the Assistant City Manager/City Clerk. Motion was made by Parrigin and seconded by Williams for first reading of said Ordinance. Mayor Wilkerson reiterated this item was presented to reject the denial by the Planning Commission and approve the rezoning. Attorney Mark Alcott, representing the contract vendee, requested approval of the zone change as presented at the public hearing. He indicated this zone change actually received two public hearings before the Planning Commission and all issues were addressed in the binding elements and met all requirements of the Comprehensive Plan and Future Land Use Map (FLUM). Mr. Alcott reported the applicant was prepared to make all road improvements on Three Springs Road as recommended in the traffic impact study but was told not to by the State since improvements for this state right-of-way were already planned. He outlined the proposed development which included a retention pond and other drainage improvements, screening, buffering and other amenities. Mr. Alcott and Engineer Lucas Slavey responded to questions regarding the retention pond and proposed drainage improvements.

Commissioner Denning expressed concern with the potential drainage issues and impact on the neighboring Silver Springs Subdivision. He stated he does not want Silver Springs to receive any more water than it already does and wants to know how the concerns of the neighborhood will be answered. Commissioner Parrigin also expressed similar concerns. Mr. Slavey stated the proposed stormwater drainage design must go through several groups for review and would be bound by the

City's stormwater regulations. He specified the proposal was to pipe as much stormwater as possible to the retention pond which was designed to also divert up to seven acres of the existing watershed away from the neighborhood as part of the drainage improvements.

Attorney Chris Davenport, representing Denise Castle an adjoining property owner in opposition to the zone change, pointed out the statements made by Mr. Alcott regarding Three Springs Road improvements not being allowed by the State as part of this development was not supported in the testimony given at the public hearing other than the specific statement made by Mr. Alcott during the hearing. He argued there was no timetable for when improvements would be made to Three Springs Road and no one from the State was present at the public hearing to provide testimony on this issue. He further argued the traffic study said improvements needed to be made with this development, but no traffic mitigation requirements were being done by the developer. He also said it was not equitable to the neighbors to have to wait for something that may or may not come sometime in the future. Mr. Davenport also commented the ground water situation did not comply with appropriate standards and neighbors worried about the impact of the development and its compatibility with the adjacent subdivision as well as concerns with no unity of ownership or accountability. He urged the Board to follow the Planning Commission's recommendation to deny the rezoning.

As a rebuttal, Mr. Alcott stated the developer agreed to do everything required in the traffic study and it was in the record that they agreed to do everything they were allowed to do by the State. Mr. Davenport reiterated there was no testimony on the record from Kentucky Transportation District 3 Chief Engineer Joe Plunk regarding what the State would or would not allow.

There was additional discussion about the development, owners association responsibilities and ability to enforce rules and governance over the homeowners association through binding elements. City-County Planning Commission Attorney Hamp Moore responded to questions about the binding elements.

Mayor Wilkerson clarified this item recommended the approval of the zone change based on the summary of evidence presented to the Planning Commission and the Board of Commissioners, the testimony before the Planning Commission, the packet provided by the Planning Commission, the summary minutes and binding elements, and with a determination the rezoning was in compliance with the Focus 2030 Comprehensive Plan as demonstrated by its compliance with the following objectives and action plan: LU-1.1.1, LU-1.1.2, LU-1.1.3 and/or TR-2.1. He confirmed an affirmative vote would reject the Planning Commission's recommendation to deny the zone change.

Commissioner Nash clarified that as a general rule he objected to voting on a first reading of an ordinance as this vote was non-binding and it was only the second vote that counted. As such, he explained he may change his vote between readings since he still had more questions and research he wanted to complete before making a final determination in the matter. Once the discussion ended, a roll call vote was taken.

Mayor Wilkerson indicated the Board engaged in a closed session held earlier in the day to discuss the pros and cons of this proposed litigation, and as a result, this item was added to the agenda for consideration. As an important issue for the City and taxpayers, Commissioner Nash explained he would be voting against this action since he believed it had already been aggressively investigated for the last two years by private attorneys, State Auditor, Attorney General, Commonwealth Attorney and

FBI, and the City has been given conflicting reports as to whether or not it could successfully win litigation. He admitted there is no question that mistakes were made related to this project. He further explained he did not believe the City will prevail in collecting any money. He also stated this action is not fiscally responsible based on the \$102,000 already spent to date and considering a conservative estimate of future litigation costs of another \$185,000. He also said he believes pursuing this action hampers the progress being made downtown, and since no money is likely to be collected. his focus is ensuring that downtown continues to grow and prosper. With no additional discussion, a roll call vote was taken,
