# MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held August 2, 2022

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on August 2, 2022. Mayor Todd Alcott called the meeting to order and provided an invocation. All present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Melinda Hill, Commissioner Sue Parrigin, Commissioner Carlos Bailey, Commissioner Dana Beasley-Brown and Mayor Todd Alcott. Absent: none. There was a full quorum of the Board of Commissioners.

## **AWARDS AND RECOGNITIONS**

Mayor Todd Alcott congratulated the Bowling Green Area Chamber of Commerce for receiving the Community and Economic Development Award (CEDA) from the Southern Economic Development Council for the work on the Transpark expansion.

#### **PUBLIC HEARING**

Assistant City Manager/Chief Financial Officer Katie Schaller-Ward conducted a public hearing for the purpose of obtaining comments from residents regarding the proposed 2022 property tax rates. She reported total real estate property growth was 5.1%, with existing property growing by 3.7% and new property growth at 1.5%. Ms. Schaller-Ward explained it was a requirement to hold a public hearing when the rate is set between the compensating rate and a rate with a 4% increase. recommended the 2022 property tax rate increase from \$0.205 to \$0.206, per \$100 of assessed value, which would be about \$1.00 more per \$100,000. There was some history of the new, existing and total growth rates of real property values provided, as well as some comparisons of the average Kentucky tax rates. It was reported there had not been an adjustment to the rate in the last four (4) years, and the \$0.206 rate would recapture years 2008 through 2017 tax rate. If the rate was increased, it could potentially add \$60,000 to the City's operating budget to assist with increased costs, and would be the first increase in property tax rates since 2003. The property tax bills are expected to be mailed out in early October and payment would be due December 31, 2022 with a 10% penalty to be applied on January 1, 2023. Following discussion, there were some concerns expressed with increasing the tax rate at the same time residents are seeing inflation and recovering from the recent tornado. Schaller-Ward agreed she would provide some detailed forecasting with revenue projections of the current rate and recommended rate. Since it was a public hearing, Schaller-Ward inquired if anyone from the public wished to speak on the issue. With no further comments, the public hearing was closed.

#### CITY MANAGER

City Manager Jeffery B. Meisel reminded the audience to sign-up in the back of the Commission Chamber in order to speak during public comments.

Meisel further requested item number 7, Ordinance No. BG2022-41, be tabled until the next Board of Commissioners meeting.

#### **PRESENTATION**

A presentation was provided regarding the Workforce Participation Project update.

President/CEO Jon Sowards of the South Central Workforce Development Board provided an overview of the Workforce Development Board initiatives and the Fort Campbell position the City helped fund. He explained the Fort Campbell position assists veteran's transitioning from the service to the workforce and said the focus was on staying connected and continue building strong recruitment efforts.

Jason Heflin of CrowdSouth provided an update on the Workforce Participation Outreach Campaign. He reviewed the project goals to encourage workforce participation locally and within the 10-county region, strategy, efforts and results. It was reported the outreach results included 3,831 applicants who clicked the "apply now" link, 107 total employers have signed up to be a part of the program, 24,253 people visited the website and 38% hiring rate for employers currently signed up. Heflin reviewed some new feature results such as projected filled positions from June 1 – July 31 was 230 and 54 job seekers requested assistance through the new "Need Help" feature, from May 11 – July 31. Mr. Heflin suggested returning next quarter for an update.

### PUBLIC COMMENTS

Following the regular agenda, Mayor Alcott opened the floor for any public comments. Eric Tuttle made remarks on the importance of preventing panhandling and the impacts it has on the community.

There being no further business to come before the Board of Commissioners, at approximately 7:30 p.m., Mayor Alcott declared this meeting adjourned.
