

### **Campaign Sign Regulations**

Campaign signs can be displayed on private property with the owner's permission, but must be away from streets and roads.

Campaign signs cannot be placed on or in any rights-of-ways or utility easements. This includes on trees, shrubs, telephone poles, traffic signs and other objects in the right-of-way. Signs erected on public property are prohibited.

No sign shall obstruct a motorist's view. There should be free and clear vision of intersections and traffic signals at all times. Signs should contain no flashing lights or moving parts (including flags/streamers/etc.).

<u>Residential properties</u> can display no more than 10 temporary signs at any time – residences on **less than 2 acres** can display signs up to <u>8 square feet</u> in size, properties over two acres can display signs up to 16 square feet in size.

<u>Commercial properties</u> can display no more than 4 temporary signs at any time – businesses **on less than 5 acres** can display signs up to 16 square feet in size, properties over five acres can display signs up to 32 square feet in size.

Larger signs may not be cut into smaller sections and then bound together.
