ORDINANCE REZONING REAL ESTATE

ORDINANCE REZONING A TRACT OF LAND CONTAINING 0.17 ACRE FROM GB (GENERAL BUSINESS) TO RM-4 (MULTI-FAMILY RESIDENTIAL) LOCATED AT 0 STATE STREET, PRESENTLY OWNED BY ROBERT E. PETRIE TESTAMENTARY TRUST, GEORGE D. LAWSON, JR., TRUSTEE WITH ROBERT AND VICKI CHAUDOIN AS THE APPLICANTS

WHEREAS, after proper notice and pursuant to applicable state statutes, the City-County Planning Commission of Warren County, Kentucky held a public hearing in City Hall on February 3, 2022 regarding the proposed rezoning of a tract of land containing 0.17 acre located at 0 State Street (formerly 636 State Street), from GB (General Business) to RM-4 (Multi-Family Residential); and,

WHEREAS, said Planning Commission found the proposed zone change to be in agreement with the adopted Comprehensive Plan; and,

WHEREAS, said Planning Commission, thereafter and during the regular meeting, at said time and place with eight (8) of the allotted eight (8) members of the Board present, voted unanimously to approve a recommendation to rezone a tract of land containing 0.17 acre located at 0 State Street, from GB (General Business) to RM-4 (Multi-Family Residential), with development plan conditions.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

- 1. The tract of real estate presently owned by Robert E. Petrie Testamentary Trust, George D. Lawson Jr., trustee with Robert and Vicki Chaudoin as the applicants, containing 0.17 acre located at 0 State Street, which tract of real estate is more particularly described on the attached maps and incorporated herein as if copied in full, is hereby rezoned from GB (General Business) to RM-4 (Multi-Family Residential), with development plan conditions.
- 2. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect

the validity of the remainder of this Ordinance.

- 3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict therewith are hereby repealed.
- 4. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on March 15, 2022, and given final reading on March 15, 2022, and said Ordinance shall be in full force and effect upon signature, recordation and publication in summary pursuant to KRS Chapter 424.
