# MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held NOVEMBER 19, 2019

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on November 19, 2019. ORDINANCE REZONING TRACTS OF LAND CONTAINING 1.1140 ACRE FROM RM-2 (TWO-FAMILY RESIDENTIAL) TO GB (GENERAL BUSINESS) LOCATED AT 0, 1024, 1028 AND 1032 KENTON STREET AND 1023, 1027, 1031 AND 1033 GREENWOOD ALLEY, PRESENTLY OWNED BY CSR BG INVESTMENTS, LLC C/O CHRIS ROBERTSON

Title and summary of Ordinance No. BG2019 – 47 was read by the Assistant City Clerk. Motion was made by Parrigin and seconded by Wilkerson for second reading of said Ordinance. Commissioner Denning stated after further review of the Planning Commission minutes and noting for the record his daughter testified at the hearing, he believed it raised a conflict of interest for him and he would be abstaining from any further participation and voting on the rezoning. Commissioner Beasley-Brown stated she believed there were many individuals who were present for the agenda item and were concerned about the rezoning and asked for clarification from City Attorney Gene Harmon on procedures for holding a new hearing. Mr. Harmon stated there were three (3) ways the Board of Commissioners could handle rezonings. The most common way was consideration based on record, including no new testimony from those who were not present at the Planning Commission hearing. A second way was to table the second reading and advertise for a new argument-type hearing where both parties were represented by attorneys. Lastly, the City had the option to hold its own hearing by tabling the item and would be required to notify and advertise the hearing, however, in this particular rezoning, time was an issue and would likely outlast the 90 days the Board of Commissioners had to act on the item.

Commissioner Beasley-Brown made a motion to table the item to hold a new public hearing due to the historic significance of the neighborhood. The motion died for lack of a second.

Mayor Wilkerson reiterated the purpose of this vote was to vote on the record that was presented by the Planning Commission and further explained the process of approving recommendations made by the Planning Commission. He then opened the floor to those who spoke at the Planning Commission hearing. Deborah Anthony and Kita Clement spoke in opposition of the proposed rezoning and on the historic significance of the neighborhood. Commissioner Beasley-Brown stated that she felt there were other areas in the City that would be appropriate for this type of She explained she would be voting no on the rezoning based on the testimony and documents presented at the public hearing, and it was her opinion the proposed rezoning was not consistent with the adopted Focus 2030 Comprehensive Plan as demonstrated by its noncompliance with the objectives and action items presented in the staff report as follows: the proposal was not compatible with the area and did not comply with LU-1.1.3; the proposal did not protect the nearby neighborhoods and therefore did not comply with LU-2.5; the proposal did not comply with LU-2.5.2 and HN-1.2 because the proposed infill development was not compatible with the surrounding area; the proposal did not comply with NCR-2.5 or NCR-2.5.3, as the applicant was proposing to demolish the historic homes located on the properties; the proposal did not comply with HN-1 and HN-1.3 because the proposal was not a suitable infill project nor would it maintain or improve the existing character and pattern of development within the area nor strengthen the nearby neighborhoods, and the proposal did not comply with HN-2.3, as the applicant planned to demolish the existing historic homes and was not building housing for low to moderate income families. Once discussion ended, Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.

#### PUBLIC COMMENTS

Following the regular agenda, Mayor Wilkerson opened the floor for any public comments about items not included on the agenda. Akisha Townsend Eaton and Laura Harper Knight spoke on the rezoning processes of the Planning Commission and the availability of public input. Carlos Bailey asked for clarification on the rezoning process for a rezoning when there is historical significance involved. Commissioner Denning explained the differences between the authority of the Board of Commissioners and the Planning Commission in regard to rezoning recommendations, and stated the City did not play a role in designating homes as historic. Mayor Wilkerson added the Historic Preservation Board was responsible for reviewing and approving any properties with historic significance.

Following a brief recess to clear the Commission Chamber, the Board of Commissioners met at approximately 5:50 p.m. in closed session pursuant to KRS 61.810 (1) (c) as previously approved.
