Summary of Municipal Order No. 2020 - 78 was read. Motion was made by Wilkerson and seconded by Parrigin for consideration of said Municipal Order. At the request of the City Manager, Neighborhood and Community Services Director Brent Childers recapped a discussion on a triennial review of the transit program and the Michael Baker International Operational Efficiency and

Management Analysis of the transit system, at a June 2019 Board of Commissioners meeting. Following the discussion in June 2019, the Board of Commissioners directed staff to work on a Request for Proposal (RFP) to hire a transit manager and a transit operator. The City hired a consultant and a RFP was issued, there were five (5) proposals received from three (3) companies and it was recommended to award the bid to RATP Dev USA for the management services and Community Action of Southern Kentucky for the operational services. In addition, Childers reviewed the structure and said RATP would have a local manager in Bowling Green to oversee things such as the handling of routes, times, types of buses, as well as managing grants, reporting and future triennial reviews; however, the operations contract with Community Action would oversee the day-today functions such as bus drivers, run routes, vehicle maintenance, bus stops and shelters. Additionally, it was said since RATP was also the transit manager for Western Kentucky University (WKU), there could be a collaboration of services at some point in the future. Following some comments, Childers confirmed City staff would not be supervising the RATP manager, however RATP would provide recommendations which would require City approval. There was mention of reporting requirements from the management and operations contractors, and Commissioner Parrigin suggested an update every six (6) months the first year. Once discussion ended, a roll call vote was taken.

MUNICIPAL ORDER SUSPENDING CERTAIN CITY CODE OF ORDINANCES AND REGULATIONS REGARDING RESTAURANT OPERATIONS DURING THE CORONAVIRUS (COVID-19)

Summary of Municipal Order No. 2020 - 80 was read. Motion was made by Nash and seconded by Wilkerson for consideration of said Municipal Order. As the sponsor of the municipal order, Commissioner Nash reviewed and recommended approval of the municipal order. referenced an article that originally appeared in Restaurant Business Magazine, which reported 18% of adults said they would not feel comfortable going to restaurants, however a larger percentage of citizens would feel more comfortable dining outside. He added it is difficult for restaurants to comply with the 33% capacity guidelines and the municipal order was designed to assist local restaurants to open up while following the Governor's guidelines. It was further said the language in the municipal order would allow a restaurant to submit an application to the City to have temporary outdoor seating, such as expanding into a parking lot, and the City would waive any necessary fees. remarked safety was important and all restaurants should be ADA compliant for the outdoor seating as well. The Mayor confirmed the municipal order would expire thirty (30) days following the lifting of the COVID-19 emergency. At the conclusion of the discussion, a roll call vote was taken.
