The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on June 7, 2016. Since the budget presentation took place at the May 17th meeting, DeFebbo reiterated the budget recommendation does not include any tax increases for the 14th consecutive year. He also explained that since the City has been able to reduce its cost footprint over the past several years, we are now able to benefit from a more robust economy and provide funding for part of the implementation of the Parks Master Plan, increase spending for the annual overlay project and new sidewalk construction, and continue to invest in stormwater as well as address capital equipment needs. Mayor Wilkerson stated this was a great budget and utilized existing tax resources very well. Mr. DeFebbo also reiterated the City's reserve balance would be increased from 20% to 25% to prepare for the next rainy day and plan for future fluctuations in the City's largest revenue source. occupational license fees. Commissioner Williams thanked all City employees for being willing to step up to take on additional responsibilities as needed over the past decade in order to keep from having to raise taxes. #### **BRIEF RECESS**

With all of the action items on the agenda completed earlier than the specified time identified on the agenda for the discussion item, Mayor Pro Tem Hill called for a brief recess at 5:15 p.m. until the appropriate time arrived to begin the discussion. The meeting resumed at 5:30 p.m. as scheduled with Mayor Wilkerson once again presiding.

# DISCUSSION CSX CLOSING OF ROBINSON AVENUE AT RAILROAD TRACKS / CROSSING

Mayor Wilkerson explained this discussion was to offer an opportunity for people to express their opinions and ideas regarding the CSX closing, especially for those directly affected by this closing. He thanked Magistrate Tony Payne for also being present during the discussion since this area was within his electoral district.

At the request of the Mayor, City Engineer Melissa Cansler provided a chronological summary of events which lead to the decision by CSX to close its right-of-way access at Robinson Avenue. She reported that CSX's original plan included the addition/extension of a second track line across Old Morgantown Road in order to provide for a longer parking area for trains waiting on other trains to pass, which would essentially block traffic from crossing the tracks at Old Morgantown Road. She explained permits were already issued and materials were onsite for this construction to begin immediately. Ms. Cansler further conveyed that CSX was not aware of the volume of traffic as well as the number of pedestrians crossing at Old Morgantown Road until they visited. In an effort to explore other options that would keep Old Morgantown Road open and have the least negative impact on the community, CSX offered to close its right-of-way at Robinson Avenue. Although City staff continued trying to get CSX to pursue other areas outside of the city limits to provide the duel tracks for waiting trains, Ms. Cansler reported CSX was not willing to consider such areas due to the cost required to build the adequate infrastructure. In order for CSX to abandon the modifications proposed at Old Morgantown Road, an agreement was reached providing that the City would be reimbursed for removing pavement, providing a turn around and adding necessary landscape and signage to prevent vehicular and pedestrian crossing of the CSX right-of-way at Robinson Avenue. Ms. Cansler stated that it was only with the signed and finalized agreement that the City was given surety Old Morgantown Road would remain unaffected.

Before opening up the discussion, Mayor Wilkerson reiterated his personal apologies for not having more information out to the neighborhood before tonight. He stated all the comments will be recorded for Commissioner Parrigin, who was unable to attend due to a prior obligation.

Brian Howard, president of the Cedar Ridge Neighborhood Association, thanked the Board for the opportunity to speak and willingness to listen. He remarked he felt the neighborhood has not been represented or had an opportunity to be heard up to this point. As he continued, Mr. Howard voiced several concerns with the closing of Robinson Avenue and presented several questions, such as how CSX had the ability to restrict access, why adjacent property owners were not notified of the street closing per statute requirements, and what other considerations were being contemplated to provide a long-term solution for neighborhood access. He also asked to see documentation about reported fatalities and how this solution would make it safer. He wanted to know what residents were supposed to do to get to the west side of the tracks when Robinson Avenue is closed to thru traffic, Emmett Avenue is blocked by a waiting train, and they cannot legally make a left turn off Creason Street onto University Boulevard.

Attorney Hamp Moore cautioned this issue was presently the subject of a lawsuit. However, he responded to some of the issues raised by Mr. Howard, including the power of the Railroad to regulate its tracks without regard to local government concerns or having to go through a street closing process. He stated the federal courts have consistently held that local governments cannot regulate Railroads. He also described the process for closing of a street and which properties would be considered adjacent to the right-of-way, but reiterated this closing did not constitute a road closure according to the City-County Planning Commission and City staff since the portion being closed was

not actually considered public right-of-way. Following a clarification from Commissioner Denning, Mr. Moore stated it was his belief CSX had the right to terminate its at-grade crossing.

Several other individuals who live in the neighborhood also came forward to voice concerns and ask questions, including Victoria Golden Thompson, Mark Boling, Katrina Miner, Kelly Thompson, Michele Boling, Jim Huston, Rebecca Adams Simpson, Aaron McCormack, Tony Harkins, Jacky Shadowen, Anna Moore and Ed Yager. Mr. Boling inquired if there was a representative from CSX present at the meeting, asked for a copy of Ms. Cansler's comments and suggested improvements be considered for Creason Street. Mr. Howard wanted to know what assurances there would be that Emmett Avenue would not be blocked. Ms. Miner asked if any studies had been done to determine the impact to the McNeil Elementary School drop-off/pick-up traffic. Mr. Thompson asserted it looked like the City was closing the road since it was going to pull up the pavement. He also expressed concerns about "tanker bombs" being parked on the tracks so close to a residential area. Ms. Boling stated she was disappointed in City leaders for not having taken a stronger stand against CSX and challenge CSX to take a harder look at a better solution. Mr. Huston indicated their neighborhood has been cut off in recent years from other traffic improvements made around WKU's campus, including from the round-about on Nashville Road. He disagreed with residents having to pay the price just so CSX could make more profits. Ms. Simpson wanted to know how the City was going to increase safety and alleviate already heavy traffic on Creason Street, University Boulevard and Russellville Road at peak times. Mr. McCormack stated he had yet to hear how the City was going to help the neighborhood. Mr. Harkins wanted to know what Robinson Avenue would look like and when it be closed to thru traffic. Mr. Thompson again asked the Board to fight CSX and to make CSX prove in court it had the ability to close the right-of-way. Ms. Boling inquired if anyone had contacted Representative Guthrie about the issue. She asserted there had not been enough alternatives explored before the City said yes to closing Robinson Avenue. Shadowen insisted the impact to traffic needed to be considered especially since it was already difficult to get out of the neighborhood when WKU athletic events were going on. Ms. Moore remarked residents in the neighborhood would be totally inconvenienced because CSX was being very selfish in its consideration. She urged the Board to find a solution to solve this problem. Mr. Yager expressed concern about CSX representatives not attending this meeting because he wanted to hear what they had to say about the issues raised. Ms. Boling encouraged the Board to withdraw from the agreement until the litigation was resolved.

In response to some of the questions raised and concerns shared, Mayor Wilkerson said he did not think any CSX representatives were in attendance and surmised that was due to the pending lawsuit. He indicated the information provided by Ms. Cansler would be posted on the City's website and made available for anyone who was unable to attend the meeting. He also confirmed the City was trying to find some alternatives for better access to the neighborhood, but all of which took time to develop.

Ms. Cansler showed some preliminary alternatives to address traffic concerns and make improvements to the intersection of Creason Street at Emmett Avenue. She also presented a preliminary design concept for proposed changes to Robinson Avenue.

Because of his knowledge about trains, Commissioner Williams responded to questions about the requirement for two parallel railroad tracks and CSX's original plan to extend the two tracks north of Old Morgantown Road. He confirmed there were no assurances that Emmett Avenue would not be blocked from time to time. He also stated he agreed with all of the concerns expressed since he lives in the same neighborhood and would be impacted just like everyone else. However, he felt his hands were tied due to the law which pre-empts local jurisdiction.

Commissioner Denning remarked about CSX coming to the City about 20 years ago wanting to close multiple crossings at the same time, which would have significantly cut off the west side of town from the rest of the city. He recounted the City was able to reason with CSX and avoid those closures. However, Commissioner Williams pointed out that the laws had changed shortly thereafter giving Railroads more control reducing local governments' ability to prevent such closures in the future.

Once those in attendance had an opportunity to speak, Mayor Wilkerson thanked everyone for coming to the meeting and for sharing their comments and concerns. He stated he wished he had a more definitive answer to some of the questions presented and remarked some of the answers will have to be worked out in court. Mr. Moore confirmed the case had been moved to federal court with U. S. District Court Judge Joseph McKinley, Jr. assigned to the case. He also confirmed that any hearings or trial would be held in Bowling Green.

Mayor Wilkerson again stated all comments from this meeting would be made available to everyone involved. With pending litigation, he also stated any further considerations or action by the Board regarding this issue would have to be made in consultation with the attorneys. The Mayor closed the discussion by reiterating the City would make every effort to share all new information as it became known.

#### ADJOURNMENT

Once the discussion ended and there being no further business to come before the Board of Commissioners, at approximately 6:45 p.m., Mayor Wilkerson declared this meeting adjourned.
