WORK SESSION

The work session was held to discuss a proposed downtown Entertainment Destination Center (EDC). Neighborhood and Community Services Director Brent Childers explained an EDC was supported and further research was recommended by the Board of Commissioners in January of 2021. Following some research the City hosted a downtown focus group in October 2021 to gather some feedback. In December 2021 a Downtown Development Coordinator was hired and later the City

hosted a downtown stakeholders meeting in February 2022 to discuss an EDC. City Attorney Hillary Hightower reviewed the process to establish an EDC, which included amending the City's Code of Ordinances, public notice requirement for thirty (30) days and state site inspection and approval of the proposed EDC zone. A proposed map of the EDC area was reviewed and included portions of Chestnut Street down to Kentucky Street, which include the highest concentration of bars and restaurants in the downtown area. The EDC would be active during special events on Friday and Saturday within the hours of 11:00 a.m. and 10:00 p.m. each day. Some examples of special events would include City hosted or sponsored events, such as, Harvest Festival, Downtown Lights Up and Concerts in the Park, as well as Bowling Green Ball Park games and events, and SKyPAC and Capital Arts hosted events. Any special events that go through the special event approval process could request activation of the EDC. Mr. Childers further said research and other cities recommended a logoed to-go cup for single-use and the EDC participants would be responsible for purchasing the cups. These designated cups would be allowable in the specified zone area. The proposed responsibilities of the City included: the Parks and Recreation Department handling clean up and waste removal: Police Department dedicated to extra patrol during EDC hours; Public Works Department installing signage and possibly additional trash cans within the zone, and the Neighborhood and Community Services Department handling the public information campaign and working closely with the EDC vendors and the state to meet requirements. There were downtown business owners and residents who expressed concerns with an EDC causing additional noise, more trash, worsened shortage of restroom facilities and unclean sidewalks and streets.

ADJOURNMENT

There being no further business to come before the Board of Commissioners, at approximately 6:50 p.m., Mayor Alcott declared this meeting adjourned.
