### BOWLING GREEN HUMAN RIGHTS COMMISSION HISTORY

The Bowling Green Human Rights Commission was established by the City of Bowling Green ordinance of 1966. The purpose of the agency is to promote fair treatment and equal opportunity for all the citizens of Bowling Green and Warren County. Our agency operates by funding from the City of Bowling Green, Community Development Block Grant (CDBG) program to promote fair housing and Warren County. The BGHRC has 2 full-time employees Alice Waddell, Executive Director and Chiquita Lightfoot, Administrative Coordinator and Fair Housing Outreach Education Coordinator. The agency has 11 board members appointed by the Mayor and City Commissioners. Our agency takes in complaints of discrimination in the areas of Employment, Housing and public accommodation based on the membership of a protected characteristics of race, color, age over 40, disability, religion, sex, national origin, and familial status in housing.

### Low Income Home Energy Assistance Program

Funded by a Community Services Block Grant (CSBG), the Low-Income Energy Assistance Program (LIHEAP) can offer relief to low-income residents on their heating and cooling costs. This assistance can, in turn, reduce the risk of health and safety concerns such as illness, fire or eviction. LIHEAP support is divided into two components, as Subsidy Component and a Crisis Component can offset heating costs based on an individual's income and primary fuel type. Benefits are paid directly to the primary fuel vendor. Enrollment for the Subsidy Component is open November–December each year. To utilize the Component, applicants must meet the same income eligibility requirements as the Subsidy Component, as well as have received a "disconnect" notice from their utility company or be within four days of running out of a non-metered fuel such as propane. Applications for the Crisis Component are accepted January–March 31. During the enrollment period for each component, applications are taken in person at the local community action office in each county.
