# MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held JANUARY 5, 2016

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on January 5, 2016. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by McNeil Elementary School 5th grader Carrington Coppinger, and all present recited the Pledge of Allegiance. Assistant City Manager/City Clerk Katie Schaller-Ward called the roll, and the following members were present: Commissioner Sue Parrigin, Commissioner Rick Williams, Commissioner Joe W. Summary of Municipal Order No. 2016 - 7 was read by the Assistant City Manager/City Clerk. Motion was made by Hill and seconded by Williams for consideration of said Municipal Order. DeFebbo recounted the previous approvals to purchase three Ford F450 trucks and the news that those trucks are no longer available due to the manufacture's recent shutdown of production. In light of these developments, he explained it has now been determined that a Ford F350 platform could meet the minimum specifications, albeit not optimal. Therefore, he recommended proceeding with purchasing under a State pricing contract.

In response to questions from the Board, Purchasing Agent Marilyn Parrigin explained the potentially lengthy time delay to wait for production of the F450 to start back up again. She also identified the cost savings by going to the new platform through State pricing. Fleet Manager Kris Crowe also responded to a question regarding the capability of the F350 platform to meet the needs of the department under these circumstances. Once all the discussion ended, a roll call vote was taken.
