# 2010: THE YEAR IN REVIEW AND A LOOK AHEAD

## ROADS AND TRANSPORTATION: BETTER WAYS TO GET AROUND TOWN

- Old Morgantown Road rehabilitation project continues and is set to be completed in September 2011.
- A new Neighborhood Traffic Control Policy and Traffic Feature Map amendment process were implemented.
- The Greenwood Lane construction project was completed and opened, allowing for improved traffic flow and economic development.



- An additional 1.5 miles of Greenways trails were developed and overseen by City staff.
- The Westside Sidewalk Initiative at Double Springs Road was completed. This includes flood mitigation improvements.

## STRONG NEIGHBORHOODS: IMPROVING INFRASTRUCTURE, EMPOWERING PEOPLE

- Ten years of Neighborhood Builders Awards were commemorated with an annual banquet and video.
- Neighborhood Action collaborated with Hill House, a groundbreaking community engagement project piloted by WKU Alive Center for Community Partnerships.
- "Healthy Neighborhood Indicators" were incorporated into the Select Neighborhood Action Program (SNAP), matching a record high number of new SNAP applicants.
- Neighborhood groups participating in Neighborhood Watch increased by more than 36%.

- The City completed the renovation of 11 single family low-income homes.
- The 2009 Target Area Inspection was completed from Beech Bend Road to Morgantown Road.

#### **DOWNTOWN REDEVELOPMENT/RIVERFRONT**

- The City of Bowling Green conveyed 600 State Street to a private business that will renovate the building under historic guidelines and create three new jobs.
- The electrical outlets at Circus Square Park were upgraded, allowing for more programs and events.
- Drainage and roadway improvements were completed at State and 7th Streets to help alleviate flooding.



# PUBLIC SAFETY: IMPROVED FACILITIES, BETTER EQUIPMENT

- The renovation of Fire Headquarters and the construction of the new BGFD administration building were completed and under budget.
- The Police Department parking lot was expanded in-house by the Public Works Department.
- All assigned patrol vehicles now have in-car cameras installed.
- Work is underway to better equip BGFD by providing online access to floor plans of structures while they are en-route to a scene.
- The Alternate 911 Center is complete and went on-line in September 2010.
- Design work was completed for the renovation of the Airport Fire Station, and construction will begin in FY2011.

# PARKS AND RECREATION: NEW AND IMPROVED FACILITIES

- A new picnic shelter was constructed in-house at Covington Woods Park.
- The revenues at Russell Sims Aquatic Center grew 2% to almost \$500,000.
- The chain-link fencing at Pioneer Cemetery was replaced with wrought iron fence, and brick columns were added.
- The tennis courts at Covington Woods Park were renovated through both in-house and contract labor.



- Over 1 million people visited our parks and facilities.
- General parks revenue increased by 8% to over \$400.000.
- The Fitness Facility purchased bicycles and now offers a Spinning Class.
- Improvements including concrete surfacing and the replacement of devices and equipment took place in the "Sprayground" at Russell Sims Aquatic Center.

#### WAYS WE'RE SAVING MONEY

- A new overtime policy and a compensatory time request procedure were implemented, saving the City an estimated \$200,000 per year in personnel costs.
- Claims for the City's self-funded employee medical and dental benefits plan were 24% under budget for FY2010 and down 3.3% compared to FY2009 paid claims.
- The City is conducting Section 8 housing inspections in-house, allowing for \$21,744 to be reimbursed into the City's General Fund.

- Regular maintenance schedules for City vehicles and equipment have been extended to reduce costs.
- A heavy truck lift was procured at no cost to the City, increasing the Public Works Fleet Division's capacity for maintenance.
- Multiple positions were combined or reorganized to save money and increase efficiency.
- Actual General Fund expenditures were down 4.9% for FY2010 compared to FY2009.
- Operating expenditures have been reduced by over \$4 million since FY2008.

#### **BETTER WAYS OF WORKING**

- City employees can now check payroll data, accrual time, personal information and other Human Resources related items for themselves with the development of the eHR online application.
- Three additional service bays were added to the Fleet Management Center, allowing for increased efficiency and ability to handle large vehicle and equipment repairs in-house.
- The Housing and Community Development Department has been re-organized, including the addition of the City Central and Neighborhood Action offices, a new triage system for code violations and a new Code Enforcement Board Clerk.



- The BGFD re-worked inspection districts to improve efficiency of inspections.
- Housing and Community Development inspectors are now equipped with wireless laptops to use in the field, increasing productivity and efficiency.
- BGPD had its safest year on record with an almost 50% drop in preventable vehicle collisions from the previous year.

#### **BETTER SECURITY**

- Additional security cameras were installed at multiple City facilities.
- Encryption software was added to all Police Department Mobile Data Computers for added security.
- 305 members of City staff participated in an online Identity Theft Protection course.
- A new driver certification program was implemented for all BGFD drivers and relief drivers.
- BGPD developed a Communications Training Officer program designed to enhance field training for new police dispatchers.



#### **BETTER PRICE TAG**

- Revenues continue to increase through the Entrepreneurial Service Initiative with Public Works Fleet Division, offering maintenance services to other agencies.
- The workers' compensation experience modification factor fell from .78 to .74, resulting in a \$23,000 insurance premium reduction.
- Multiple departments collaborated to more efficiently collect parking ticket fines and track repeat offenders.

#### DISTINCTIVE

- The City was recertified as a "Drug-Free Workplace" through the KY Department of Workers' Claims; the City received a 5% workers' compensation premium savings of approximately \$19,000.
- Lost-time injury rates for City employees (injuries requiring at least one day off of work) fell to the lowest level since FY1996.

- The use of Process Action Teams encourages employees to work together on City problems and initiatives.
- Preventable collisions involving City vehicles were reduced for the fourth consecutive year.

#### **OUTSTANDING**

- Ten training sessions were coordinated and facilitated for 207 employees and 80 supervisors on ADA and FMLA law changes and how to prevent harassment in the workplace.
- City Central coordinated the annual Veterans
  Day Parade in the downtown area and the Historic
  Downtown Lights Up event at Fountain Square Park.



- BGPD achieved a 100% on the Kentucky League of Cities scorecard for law enforcement agencies. Less then 1% of police agencies have achieved this recognition.
- Energy efficiency improvements continue to be implemented in City-owned buildings and a partnership was formed with BRADD to make funds available to 23 homeowners for energy efficiency improvements.
- The C.O.V.E.R. (Code Offense Volunteer Eligible Repair) program was developed and will assist property code violators who do not have the means to bring their property into compliance.

#### **HIGH PERFORMING**

- The Section 8 Program received a rating of "High Performing Agency" from HUD. We have received this rating 8 out of 9 years.
- 38 safety-related courses provided 493 employees with over 1,050 hours of instruction.
- Finance received the GFOA Certificate of Excellence in Financial Reporting for the FY2009 Consolidated Annual Financial Report.

• The second annual Internal Control and Fraud Awareness training was conducted for all City funded agencies and City staff.

# FISCAL YEAR 2011 KEY BUDGET RECOMMENDATIONS

- The entire City budget only increased by 1.6% this year compared to last year's adopted budget. The General Fund expenditure budget decreased by 2.4% from the previous year.
- A General Fund reserve balance of 15% of revenues was maintained in accordance with adopted policy.
- There were no new General Fund financed projects in FY2011. The total adopted Capital Improvement Program, including debt, is \$16.9 million.
- \$911,000 in state funds will be used to maintain streets and sidewalks as part of the City's annual overlay and reconstruction program.
- Approximately \$650,000 will be devoted to improve stormwater drainage issues by improving old structures or creating new ones through the new Stormwater Mitigation Program.
- \$400,000 will be used from the Technology Fund to replace computer equipment and operating systems.



- Fire equipment will be replaced and upgraded at a cost of \$219,500.
- Improvements to the Police Department's firing range are expected in FY2011 at an estimated cost of \$150,000.
- Approximately \$500,000 will be invested in capital improvement projects at the Sloan Convention Center.


