MINUTES of SPECIAL MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held June 2, 2020

The Board of Commissioners of the City of Bowling Green, Kentucky met in special session via Lifesize video teleconference due to the Coronavirus (COVID-19) pandemic at 2:00 p.m. on June 2, 2020. Mayor Bruce Wilkerson called the meeting to order and called the roll, and the following members were present: Commissioner Dana Beasley-Brown, Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

CITY MANAGER COMMENTS

City Manager Jeffery B. Meisel recognized newly hired City Attorney Hillary Hightower and she made some remarks. Meisel further indicated the City was wrapping up with the Fiscal Year 2021 budget and indicated some budget cuts were made, however more details would be provided in a video presentation and posted on the City's website and social media. The first reading of the budget was scheduled for June 16th and the second reading would follow by the end of June. In addition, Meisel explained City offices would be opening on June 15th with some additional modifications to offices, but with limited staff and continued telework. A statement recently issued by the City of Bowling Green related to the recent incident in Minneapolis, Minnesota and the death of George Floyd was read by Meisel.
