MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held SEPTEMBER 6, 2016

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on September 6, 2016. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Police Chaplain Mike Holian, and all present recited the Pledge of Allegiance. Assistant City Manager/City Clerk Katie Schaller-Ward called the roll, and the following members were present: Commissioner Sue Parrigin, Commissioner Rick Williams, Commissioner Joe W. Denning, Commissioner Melinda M. Hill and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

PUBLIC HEARING

Neighborhood and Community Services Director Brent Childers conducted a public hearing for the purpose of reviewing and receiving comments on proposed substantial amendments to the Annual Action Plans for Years 7 and 10 of the Community Development Block Grant (CDBG) Program. He reported a total of \$32,206 of unspent funds would be reallocated to United Way of Southern Kentucky for its new 2-1-1 initiative. The CDBG money would be used to reimburse United Way for calls received from Bowling Green residents. Mr. Childers stated the comment period regarding these Plan amendments would remain open through September 16, 2016.

Commissioner Hill inquired where the balance of the proposed \$50,000 total allocation to United Way would come from. Mayor Wilkerson indicated it would be from the general fund. Commissioner Parrigin commented about the benefits of this new program. There were no other public comments.

Mayor Wilkerson announced the retirements of Parks/Golf Maintenance Superintendent Tony Whitmer and Assistant Fire Chief Donnie Frye both with 21 years of service, and wished them well.

CITY MANAGER

City Manager Kevin D. DeFebbo requested a closed session for the purpose of discussion about the sale of real property by the City as publicity would likely affect the value of the specific piece of property to be sold, and for discussion of pending litigation against the City.
