


Whether in 1908 or 2008, we remain committed to four overriding principles:


- To provide for open, honest representative government.

ROADS AND TRANSPORTATION: BETTER WAYS TO GET AROUND TOWN

COMING SOON

- The preliminary design for the Old Morgantown Road project was completed, and funding for the final design was set aside.
- Funding was committed and the Phase I design for the Cave Mill Road and Smallhouse Road intersection was initiated.
- The Greenwood Lane project was funded in the FY2009 budget.
- Funding was set aside for the extension of Kawanishi Way.
- Over \$1.2 million will be used to build and rehabilitate sidewalks throughout the city.

WHERE ELSE WE'RE INVESTING

- 7,268 feet of new sidewalks were laid.
- Phase I of the Westside sidewalk initiative at Clay Street and W. 13th Avenue was completed.
- Construction of the Broadway curve realignment project began.



- Construction of the downtown signalization project was initiated.
- Partnered with the Kentucky Transportation Cabinet, Warren County and affected property owners to fund underground utilities along parts of Lovers Lane.
- New greenways were completed connecting Weldon Peete Park to the College Street Bridge.
- Westen Avenue realignment was completed through a public-private partnership.
- Phase II of Heritage Trail was completed, providing a landscaped walkway from Fountain Square Park to Circus Square Park.
- Improvements to Modern Way were completed, allowing for alternate access to the industrial park.
- Phase II of the Fields Drive extension was completed allowing internal traffic to avoid the Campbell Lane and Nashville Road intersection.

STRONG NEIGHBORHOODS: IMPROVING INFRASTRUCTURE, EMPOWERING PEOPLE

- Eight of the 12 Lee Square Phase I homes constructed by HANDS and the Housing Authority were sold and occupied.



- Construction on an additional five homes in the Lee Square development was initiated by the Housing Authority.
- Twenty-six homes on Edward Drive and Cedarwood Way were annexed into the city.
- The Mayor's Task Force on Regulatory Reform identified barriers to affordable housing and its recommendations were adopted by the Board of Commissioners.
- Nearly 3,000 properties were inspected through the Target Area proactive property maintenance inspection program.
- With neighborhood input through Envision Forest Park, a preliminary design was completed to rehabilitate Old Morgantown Road.

- “Make a Difference in Your Neighborhood” information fair was initiated by the BGCAN Board.

- The neighborhood park at Lee Square was completed.

- A partnership was formed with the Bowling Green Housing Authority for the demolition and development of dilapidated properties on E. 3rd Avenue.

- Circus Square Park opened.




- Rehabilitation of the Standard Oil Building at Circus Square Park was authorized.

- The City issued \$25 million in General Obligation bonds for the construction of the minor league ballpark.

- The City approved the WKU Gateway to Downtown Bowling Green mixed-use Tax Increment Financing (TIF) District, a multi-year public-private partnership that will redevelop several blocks, including a baseball stadium, hotel, retail and office space, residential properties, the Southern Kentucky Performing Arts Center, and related parking and public infrastructure improvements.

PUBLIC SAFETY: A SAFER COMMUNITY

- Five additional firefighter positions were authorized to complete staffing of the new Greenwood Fire Station.



- Two additional police officers and two communications positions were authorized.
- An online bicycle registry was initiated at www.bgky.org.



- Security cameras were installed at the City Hall complex and the Russell Sims Aquatic Center.
- Two fire trucks were replaced.
- Design was started for the improvement and addition to the Fire Department Headquarters.

- New thermal imaging equipment was purchased for the Fire Department.
- An Emergency Response Vehicle was purchased for the BGD Critical Incident Team.

PARKS AND RECREATION: CONTINUED GROWTH

- New Kereiakes Park tennis courts were built.



- New restrooms were built at Lampkin Park.
- A new basketball court and parking lot were built at Preston Miller Park.
- Over 1.1 million participants enjoyed parks services last year.
- A new pump and filter system was installed in the fountain at Fountain Square Park.



- Parks and Recreation revenues were up 6% this year totaling over \$2.5 million.
- Improvements were made to the Paul Walker Pro Shop and restrooms.



WAYS WE'RE SAVING MONEY

- The Kummer/Little Recreation Facility opened and is being operated with one additional part-time recreation staff and by using personnel from other programs.



- \$324,500 in additional new revenues was produced through business license audits and inspections.
- The Public Works Operations Division used in house personnel and resources to install sidewalks on Wilkinson Trace, E. 3rd Avenue, Gordon Avenue and W. Main Street.



- Parks Maintenance staff installed a lighting system at the new Kereiakes tennis courts.
- The FY2009 budget totals \$94.4 million, 8.6% less than the previous budget.
- A new Convention Center management and catering agreement resulted in an increased City share of revenues over the next two years.

- Public Works Fleet Division installed 72 Mobile Data Computers in patrol cars.
- The City was certified as a “drug free workplace” through the Kentucky Department of Workers Claims, providing a 5% savings in our Workers’ Compensation premium.
- The Smith System Certified Driver Training Program was initiated to reduce accidents.
- A new 10-year gas franchise agreement was approved with Atmos Energy.


BETTER WAYS OF WORKING

- Parks and Recreation worked with Public Works to transfer right-of-way mowing from the Landscape Division.
- New World Software System for the Finance and Human Resources departments was implemented. This system will allow for improvements with asset management, project accounting, purchasing, payroll, benefits, position control, and applicant tracking.
- 360 access points were deployed as part of the new wireless technology network which will greatly assist Police, Fire, and Housing and Community Development.



- As part of our wireless technology project, a Homeland Security Grant paid for 100 additional access points to be installed in FY2009.

- Golf audit recommendations were implemented, including volunteer and alcohol beverage policies.
- The Finance Department assisted with the transition from credit cards to procurement cards that will add more internal control and security.
- The Public Information Division began producing original programming for Government Access Channel 4 and the website.
- A school crossing assessment was completed to improve efficiency and safety for walkers and bikers.
- A long term maintenance plan for various municipal facilities was implemented.
- Disaster recovery IT equipment was installed at the Southside Fire Station and began backing up critical data there.
- Mobile Data Computers were implemented, improving officer safety and efficiency.



- Human Resources took over portions of the payroll function to accomplish a separation of duties as recommended by the City's auditor.
- Six job development incentive agreements were coordinated and are expected to produce 156 new jobs and net \$529,000 in withholdings over the next five years.

- The wetland filtration storm water project at Lost River Cave to naturally treat stormwater run-off from Nashville Road was approved and initiated.



- Performance measurement standards were developed for City departments utilizing the ICMA Center for Performance Measurement.
- Work on the County-wide Strategic Comprehensive Plan was initiated. Eight public forums were held and work began on the creation of a Vision Statement and draft plan elements for land use, transportation and community facilities.


- Forbes Magazine ranked Bowling Green as the twelfth Best Small Place for Businesses & Careers in the U.S. for metro areas under 250,000.



- The Finance Department received the Government Finance Officers Association of the United States of America Certificate of Excellence in Financial Reporting for the FY2007 comprehensive annual financial report.
- Four City public information projects received Markie Awards from the Professional Marketing Association.
- Bowling Green was one of six U.S. cities to receive a 2008 Ambassador Cities designation by the National Association of Realtors and the U.S. Conference of Mayors, for homeownership efforts and first time homebuyer counseling.
- Bowling Green was awarded a Preserve America grant from the U. S. Department of Interior and First Lady Laura Bush.



- The Section 8 Housing Choice Voucher program was awarded an additional 97 rental assistance vouchers in December 2007.
- \$42,000 was provided to the Friends of L&N Depot to complete capital improvements.

HIGH PERFORMING

- The City's workers' compensation program was evaluated as having a perfect score and received a risk management award from the Kentucky League of Cities Insurance Services.



- The Fire Department received national accreditation by the Commission on Fire Accreditation International.



- The Police Department was recertified for another five years by the Kentucky Association of Chiefs of Police.



- The new Kummer/Little Recreation Center received the May 2008 Operation P.R.I.D.E. Commercial Pride Award for improving the appearance of the 300 block of College Street.
- The Fleet Management Division received the National Institute for Automotive Excellence "Blue Seal of Excellence" for the fifth consecutive year.





- City departments worked together to initiate a Hispanic community outreach effort.

FISCAL YEAR 2009 KEY BUDGET RECOMMENDATIONS

- All non-public safety departments were directed to cut their FY2009 operating budget requests by 3%.

L&N Depot



- The FY2009 budget is based on a lower property tax rate to account for elimination of direct City funding of the public library due to implementation of a county-wide library tax.



- The total adopted Capital Improvement Program, including debt, is \$18.8 million.



- The budget recommended no new bonded debt.
- A dedicated special fund reserve of almost \$2 million was established to protect against possible revenue shortfalls to make TIF or ITA bond payments.
- A General Fund reserve balance of 15% of revenues will be maintained in accordance with adopted policy.
