MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held August 15, 2023

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on August 15, 2023. Mayor Pro Tem Sue Parrigin called the meeting to order. Director Landon Harting of Western Kentucky University Wesley Foundation provided the invocation and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Carlos Bailey, Commissioner Dana Beasley-Brown, Commissioner Melinda Hill and Mayor Pro Tem Sue Parrigin. Absent: Mayor Todd Alcott. There was a quorum of the Board of Commissioners.

PUBLIC HEARING

Assistant City Manager/Chief Financial Officer Katie Schaller-Ward conducted a public hearing for the purpose of obtaining comments from residents regarding the proposed 2023 property tax rates. She reported total real estate property growth was 6%, with existing property growing by 2.7% and new property growth at 3.3%. Ms. Schaller-Ward explained it was a requirement to hold a public hearing when the rate is set between the compensating rate and a rate with a 4% increase. She recommended the 2023 real property tax rate remain the same at \$0.205 and personal property tax rate at \$0.260. There was some history of the new, existing and total growth rates of real property values provided, as well as comparisons of revenue calculations for Fiscal Year 2023 and Fiscal Year 2024, and the average Kentucky tax rates. It was reported there had not been an adjustment to the rates in five (5) years and Schaller-Ward indicated a failure to increase rates in the future may have a negative impact on bond ratings. The property tax bills were expected to be mailed out in early October and payment would be due December 31, 2023 with a 10% penalty to be applied on January 1, 2024. Since it was a public hearing, Schaller-Ward inquired if anyone from the public wished to speak on the issue. With no further comments, the public hearing was closed.
