MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held March 15, 2022

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on March 15, 2022. Mayor Todd Alcott called the meeting to order and provided an invocation. All present recited the Pledge of Allegiance. Following some questions from Commissioner Bailey, Neighborhood and Community Services Director Brent Childers explained the fine increase was recommended to encourage compliance for serious violations, and he further clarified all individuals may appeal violations to the Code Enforcement and Nuisance Board. Once discussion concluded, Mayor Alcott asked for a roll call vote.

Title and summary of Ordinance No. BG2022 - 13 was read by the City Clerk. Motion was made by Parrigin and seconded by Alcott for the first and non-binding reading of said Ordinance. Mayor Alcott introduced the ordinance as the sponsor and said the salary of the Commissioners had not been adjusted since 1999 and was required to be done by the first Monday in May of an election year per Kentucky Revised Statute. Additionally, he said the salary change would not take effect until January 1. 2023, following the election and may or may not include the current elected officials. However, he clarified the amendment would not change the Mayor's salary, only the Commissioners. The reason he recommended a \$31,500 annual salary was to bring the pay to at least a \$15 per hour rate. Alcott added on July 1st all City employees would be eligible for over an 8% increase in pay, to include the Cost of Living Adjustment (COLA) and a step raise. There was also discussion about the Board of Commissioners agreeing at the Strategic Goal Planning Work Session to being open to adjusting employees pay in order to become more competitive with other agencies and retain employment. Commissioner Parrigin mentioned the 2008 Salary Task Force Committee created by the City, of which she was a member, recommended a salary adjustment but it was never approved by the Board of Commissioners. Commissioners Bailey and Beasley-Brown expressed concern about using taxpayers' money to increase Commissioners' salaries, rather than ensuring employees are paid sufficiently. As a result, they indicated they would be voting against the ordinance. Mayor Alcott asked for discussion. and with none, a roll call vote was taken.

WORK SESSION

Following a brief recess at 6:10 p.m., a work session began at 6:15 p.m. At the request of the Board of Commissioners, continued discussion was had regarding a proposed downtown Entertainment Destination Center (EDC). Neighborhood and Community Services Director Brent Childers explained some further research showed a high percentage of events throughout the entire year and he would propose the EDC be every Friday and Saturday, rather than during scheduled events. Furthermore, it was proposed to have the EDC time from 11:00 a.m. - 10:00 p.m., however he could see moving the end time up to 9:00 p.m. It was reported of the twenty-two (22) downtown licensed businesses City staff polled, the responses of an EDC were as follows: fourteen (14) agreed, four (4) no, three (3) undecided and one (1) no response. Parks and Recreation Department, Public Works Department and Police Department Directors spoke about each of the department's roles to address cleanliness on City parks, sidewalks and streets, public use of restrooms, as well as addressed safety and police presence. City Manager Jeff Meisel reiterated the City would not be responsible for cleaning and maintaining private property. Following public comments and some additional discussion, the Board of Commissioners unanimously decided to move forward with an ordinance to obtain a license with the state for an EDC every Friday and Saturday from 11:00 a.m. - 9:00 p.m. It was said the ordinance language would include the licensing and map area details, and any further details of the EDC would be determined by staff.

CLOSED SESSION

Following a brief recess to clear the Commission Chamber, the Board of Commissioners met at approximately 8:05 p.m. in closed session pursuant to KRS 61.810 (1) (b) as previously approved.

There being no further business to come before the Board of Commissioners, at approximately 8:15 p.m., Mayor Alcott declared this meeting adjourned.
