The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on December 5, 2017. Mayor Bruce Wilkerson called the meeting to order. An invocation was given by Commissioner Brian "Slim" Nash, and all present recited the Pledge of Allegiance. Assistant City Manager/City Clerk Katie Schaller-Ward called the roll, and the following members were present: Commissioner Sue Parrigin, Commissioner Rick Williams, Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

MUNICIPAL ORDER AUTHORIZING AND ACCEPTING BID #2018-36 FOR THE SLOAN CONVENTION CENTER INDUSTRIAL DISHWASHER FROM HOTEL & RESTAURANT SUPPLY, INC. OF NASHVILLE, TENNESSEE IN THE AMOUNT OF \$118,599

Summary of Municipal Order No. 2017 - 246 was read by the Assistant City Manager/City Clerk. Motion was made by Nash and seconded by Williams for consideration of said Municipal Order. DeFebbo reviewed and recommended the bid award which will also require approval from The Convention Center Corporation. Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.

#### **WORK SESSION**

Fire Chief Jason Colson presented an analysis of existing and anticipated conditions regarding the ability to provide the best possible fire protection services to the residents and businesses of Bowling Green. He stated he prepared an evaluation of services using travel time, demand for services, future growth needs, traffic features and personnel available. Chief Colson summarized the methodology used to complete the evaluation and provided statistics for current travel time and showed specific examples to illustrate the results. He recommended the addition of a new fire station to service the Lovers Lane area and relocating the Northside Fire Station currently on Porter Pike to be more central to its district and closer to the Kentucky Transpark. Chief Colson confirmed no additional personnel, equipment or fire apparatus would be required for the relocation of the Northside Fire Station, only construction of the new facility would be required. He also confirmed the training center would continue to operate at the existing Porter Pike location. To outfit the new station in the Lovers Lane area, Chief Colson recommended hiring nine new firefighters, at a first year cost of approximately \$802,000 with \$61,000 of that amount being for one-time costs, which hiring could be phased-in over two to three years. He reported six existing positions and one existing fire apparatus would also be reassigned to this new station to provide a total of 15 shift personnel.

In response to questions from the Board, Chief Colson reiterated all run times and locations would be taken into consideration to find the most optimal location for each new station. He also mentioned the Fire Improvement Fund would cover the costs related to property acquisition, design and construction of the two new stations. At the request of the Mayor, Chief Colson agreed to look at the construction of a new access road around the Airport or potential relocation of the Airport Fire Station closer to Lovers Lane to avoid having to build a new station requiring additional personnel. However, he clarified the Airport posed other requirements for service delivery which would also have to be taken into consideration as part of that evaluation. With no objections by the Board, DeFebbo confirmed the next step in this process would include an analysis of idealized locations for the new stations to be presented to the Board at a future date.

#### PUBLIC COMMENTS

Following the conclusion of the regular agenda, Mayor Wilkerson opened the floor for any public comments about items not included on the agenda. Seth Peckham urged passage of a fairness ordinance to end discrimination against LGBTQ individuals. He indicated since the Board of Commissioner has been unwilling to adopt a fairness ordinance, it sends a message the City does not support all of its residents.

Mike Ayers said he wants to sell his parents' property at 750 Pearl Street to the City and does not understand why it was not already purchased by the City as part of the Whiskey Run expansion back in the 1970s since all of the surrounding properties were. He described the current condition of the property including drainage structures and flood zone area. Mr. Ayers remarked he appreciated the City's recent offer to pay for easement rights at \$2,400, but he would rather sell the property and thought \$6,100 was reasonable compensation. Both Commissioners Denning and Nash expressed an interest in purchasing the property.

Jennifer Morlan said the City needed to provide Fire protection and a Police Officer assigned to take care of fraud. She noted the next election year was coming and people were getting tired of nothing getting done.

Adeleke Ademuyewo invited everyone to attend Western Kentucky University's graduation ceremony on Saturday, December 9<sup>th</sup>.

## **ADJOURNMENT**

There being no further business to come before the Board of Commissioners, at approximately 5:50 p.m., Mayor Wilkerson declared this meeting adjourned.
