



In collaboration with Warren County Public Schools, the Operations Division paved a section of roadway connecting Dragon Street to the Early Learning Academy and extending to Loop Street. This project was initiated and completed within just one week, effectively addressing an urgent traffic congestion issue during drop-off and pick-up times. Public Works crews were responsible for preparing the paving the roadway, and area, installing the necessary signage. (September 8–12)





Heavy rains on <u>4 September</u> resulted in the temporary flooding of the Fairview Plaza parking lot. During the event, the newly installed flashing signs activated and warned motorists of the danger.

Traffic Study Update for All Way Stop Request

The P&D division is currently conducting a traffic study regarding an All Way Stop request at the intersection of Hampton Dr & Cardinal Way. This request aims to improve traffic flow and enhance pedestrian crossings, particularly due to its close proximity to Potter Grey Elementary School.


As part of the warrant study in accordance with the MUTCD (Manual of Uniform Traffic Control Devices), a turn count assessment was carried out on September 16th. MUTCD is the definitive source for guidance on these types of requests and is published by the Federal Highway Administration.

The traffic study is expected to conclude next month, providing results and recommendations for any necessary improvements to the intersection.

Several citizens requested a design change to increase the turn radius at the intersection of Lehman Avenue and Covington Street. Civil Engineer Trevor Cline, along with members of our Operations Division, conducted an analysis of the intersection and performed hydro excavation to evaluate potential options. ASPHALT PRESERVATION





Several staff members traveled to the Nashville, Tennessee area to assess asphalt treated with a maltene rejuvenator. Maltenes, a natural constituent of asphalt, play a crucial role in its longevity. A vendor demonstrated various locations where historical applications occurred, illustrating the significant impact these products can have on asphalt preservation. This year, the Public Works department was allocated \$200,000 to initiate a pavement preservation program. (September 11)


