# MINUTES of SPECIAL MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held APRIL 21, 2020

The Board of Commissioners of the City of Bowling Green, Kentucky met in special session via Lifesize video teleconference due to the Coronavirus (COVID-19) pandemic at 2:00 p.m. on April 21, 2020. Mayor Bruce Wilkerson called the meeting to order and called the roll, and the following members were present: Commissioner Dana Beasley-Brown, Commissioner Joe W. Denning, Commissioner Brian "Slim" Nash, Commissioner Sue Parrigin and Mayor Bruce Wilkerson. Absent: none. There was a full quorum of the Board of Commissioners.

#### **EXECUTIVE ORDERS**

Mayor Wilkerson reviewed Executive Order Nos. 2020-1 and 2020-2, which were recently executed by the Mayor due to the Coronavirus (COVID-19) pandemic. Executive Order No. 2020-1 was related to the extension of the deadline for the filing of net profit returns, payment of net profit fees and the waiver of interest and penalties if paid in full on or before July 15, 2020, and Executive Order No. 2020-2 was related to providing leave for employees under the Families First Coronavirus Response Act.

#### CITY MANAGER

City Manager Jeffery B. Meisel highlighted the City's operations from the last five (5) weeks during the COVID-19 pandemic. He stated the City was continuing to do business through modified and alternating schedules and explained the main switchboard was available during normal business hours, as well as essential departments such as Police and Fire. He further mentioned Parks and Recreation maintenance were doing its part to keep parks facilities maintained and cleaned, with some modifications to some parks facilities, and added Police recently started changing shifts from vehicles in order to practice social distancing. Meisel recognized the work of the Information Technology Department and Public Information office for coordinating the Board of Commissioners meeting through Lifesize video teleconference. It was noted the Finance Department was in the process of preparing a balance budget, however the budget would be presented later than usual.
