The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on May 3, 2022. Mayor Todd Alcott called the meeting to order. An invocation was provided by former nurse and volunteer chaplain at Med Center Health Vivian McClellan, and all present recited the Pledge of Allegiance.
