ORDINANCE AMENDING CODE OF ORDINANCES

ORDINANCE AMENDING CHAPTER 11 (FINANCE, TAXATION AND ECONOMIC DEVELOPMENT) OF THE CITY OF BOWLING GREEN CODE OF ORDINANCES TO AMEND THE COMPOSITION OF THE JOB DEVELOPMENT INCENTIVE PROGRAM COMMITTEE

WHEREAS, from time to time, the City of Bowling Green reviews its Code of Ordinances for compliance with applicable state law and current needs; and,

WHEREAS, a review of Chapter 11 (Finance, Taxation and Economic Development) indicated a need to amend the composition of the Job Development Incentive Program Committee; and,

WHEREAS, this amendment is in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

- 1. Chapter 11 (Finance, Taxation and Economic Development) is hereby amended as follows:
 - 11-6 JOB DEVELOPMENT INCENTIVE PROGRAM.

. . .

- 11-6.04 Job Development Incentive Program Committee; Committee Duties; Program Manager and Duties.
- a. There is hereby created a Job Development Incentive Program Committee composed of four (4) members as follows:
 - 1. The Mayor;
 - 2. <u>Two A members of the Board of City Commissioners</u> nominated by the Mayor and approved by the Board of Commissioners;
 - 23. The City Manager; and,
 - <u>34.</u> The Chief Financial Officer as an ex-officio, non-voting member.

The members of the Board of City Commissioners shall serve for their his two year term of

office. All other members of the Committee shall serve so long as he holds that position.

- 2. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.
- 3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.
- 4. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on <u>December 18</u>, 2012, and given final reading on <u>January 15</u>, 2013, and said Ordinance shall be in full force and effect as of January 1, 2013, recordation and publication in summary pursuant to KRS Chapter 424.
