

**MINUTES of REGULAR MEETING
of the BOARD of COMMISSIONERS
of the CITY of BOWLING GREEN, KENTUCKY
held March 2, 2021**

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on March 2, 2021. Mayor Todd Alcott called the meeting to order. An invocation was given by Senior Pastor of Crossland Community Church Gregg Farrell and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Carlos Bailey, Commissioner Dana Beasley-Brown, Commissioner Melinda Hill, Commissioner Sue Parrigin and Mayor Todd Alcott. Absent: none. There was a full quorum of the Board of Commissioners.

AWARDS AND RECOGNITIONS

Mayor Alcott recognized Code Enforcement Inspector Brad Schargorodski for receiving the Fire Department Citizen Heroism Award for his conspicuous act of valor and heroism under hazardous conditions in which he was placed in a life threatening position to save the life of another person. On January 29, 2021, Mr. Schargorodski entered a burning house to rescue a resident and provided shelter in his vehicle.

City Manager Jeffery Meisel said the National Recreation and Park Association named Special Populations Instructor Cameron Levis one of their 30 best and brightest young parks and recreational professionals in the field. The selection was based on impacts on the agencies community and service population, contributions to the professional development and innovative ideas, programs and/or research in the field of parks and recreation.

In addition, Public Works Inspector Joe Webb was recognized by WNKY as a Hidden Hero for his dedication to the Public Works Department over the last 28 years. Meisel also announced Fire Equipment Mechanic Jordan Stice of the Public Works Fleet Division received his Emergency Vehicle Technician II certification. Furthermore, Public Works Director Greg Meredith was acknowledged for being appointed by the Governor to the State Board of Licensure for Professional Engineers and Land Surveyors.

CITY MANAGER

City Manager Meisel requested a closed session for deliberations on the future acquisition or sale of real property by the City, but only when publicity would be likely to affect the value of a specific piece of property to be acquired for public use or sold by the City, and for discussions of proposed or pending litigation against or on behalf of the City. Motion was made by Parrigin and seconded by Hill to convene in closed session following the regular meeting pursuant to KRS 61.810 (1) (b) and (c). Mayor Alcott called for roll call vote.

PRESENTATION

President/CEO John Sowards of the South Central Workforce Development Board provided an overview of the mission, purpose and explained the board was made up of 23 members. He touched on community partners and programming which serves employers and job seekers. Employer programs such as hiring events, recruitment services, labor insights and targeted advertising were some services provided, as well as the job seeker programs which included short-term training, on the job training and work based learning.

Meisel explained the City started the BG Cares Small Business program with about \$1,885,000 in CARES Act funding and provided an overview of the program. He added there was a need for some additional money and the funding would be allocated from the second round of CARES Act funding. Neighborhood and Community Services Director Brent Childers recommended approval of the amendment which included additional funding in an amount up to \$500,000 to assist with the received and approved applications of those qualified small businesses, and Childers added no additional applications were being accepted, as the program closed on February 2nd. A total of 587 applications were received, some of which were ineligible and/or did not meet the program guidelines.
