A petition was filed with the Office of City Clerk by approximately 188 residents of the Glen Lily Road, Briggs Hill Road, Price Chapel Road and Barren River Road area strongly opposing the sale of property for the purpose of a motorsports park and the reasons included, but were not limited to, the following: traffic, noise, disturbance of the landfill, rezoning, risks associated with socializing and other undesirable recreational activity, increased demand for emergency personnel services, and the negative effect on property value.

Following a brief recess to clear the Commission Chamber, the Board of Commissioners met at approximately 5:30 p.m. in closed session pursuant to KRS 61.810 (1) (b) and (c) as previously approved.
