ORDINANCE REZONING REAL ESTATE

ORDINANCE REZONING A TRACT OF LAND CONTAINING 15.7146 ACRES FROM AG (AGRICULTURE), RM-3 (TOWNHOUSE/MULTI-FAMILY RESIDENTIAL) AND HB (HIGHWAY BUSINESS) TO RM-3 (TOWNHOUSE/MULTI-FAMILY RESIDENTIAL) LOCATED AT 0 CHERRY FARM LANE, PRESENTLY OWNED BY FAWBUSH PROPERTIES, LLC WITH A HIMALAYA KY PROPERTIES, LLC AS THE APPLICANT

WHEREAS, after proper notice and pursuant to applicable state statutes, the City-County Planning Commission of Warren County, Kentucky held a public hearing via video teleconference on April 1, 2021 regarding the proposed rezoning of a tract of land containing 15.7146 acres located at 0 Cherry Farm Lane, from AG (Agriculture), RM-3 (Townhouse/Multi-Family Residential) and HB (Highway Business) to RM-3 (Townhouse/Multi-Family Residential); and,

WHEREAS, said Planning Commission found the proposed zone change to be in agreement with the adopted Comprehensive Plan; and,

WHEREAS, said Planning Commission, thereafter and during the special call meeting, at said time and place with nine (9) members of the Board present, voted unanimously to approve a recommendation to rezone a tract of land containing 15.7146 acres located at 0 Cherry Farm Lane, from AG (Agriculture), RM-3 (Townhouse/Multi-Family Residential) and HB (Highway Business) to RM-3 (Townhouse/Multi-Family Residential), with development plan conditions.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

1. The tract of real estate presently owned by Fawbush Properties, LLC with A Himalaya KY Properties, LLC as the applicant, containing 15.7146 acres located at 0 Cherry Farm Lane, which tract of real estate is more particularly described on the attached maps and incorporated herein as if copied in full, is hereby rezoned from AG (Agriculture), RM-3 (Townhouse/Multi-Family Residential) and HB

(Ordinance No. BG2021 - 22)

(Highway Business) to RM-3 (Townhouse/Multi-Family Residential), with development plan conditions.

2. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.

3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict therewith are hereby repealed.

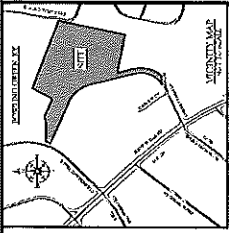

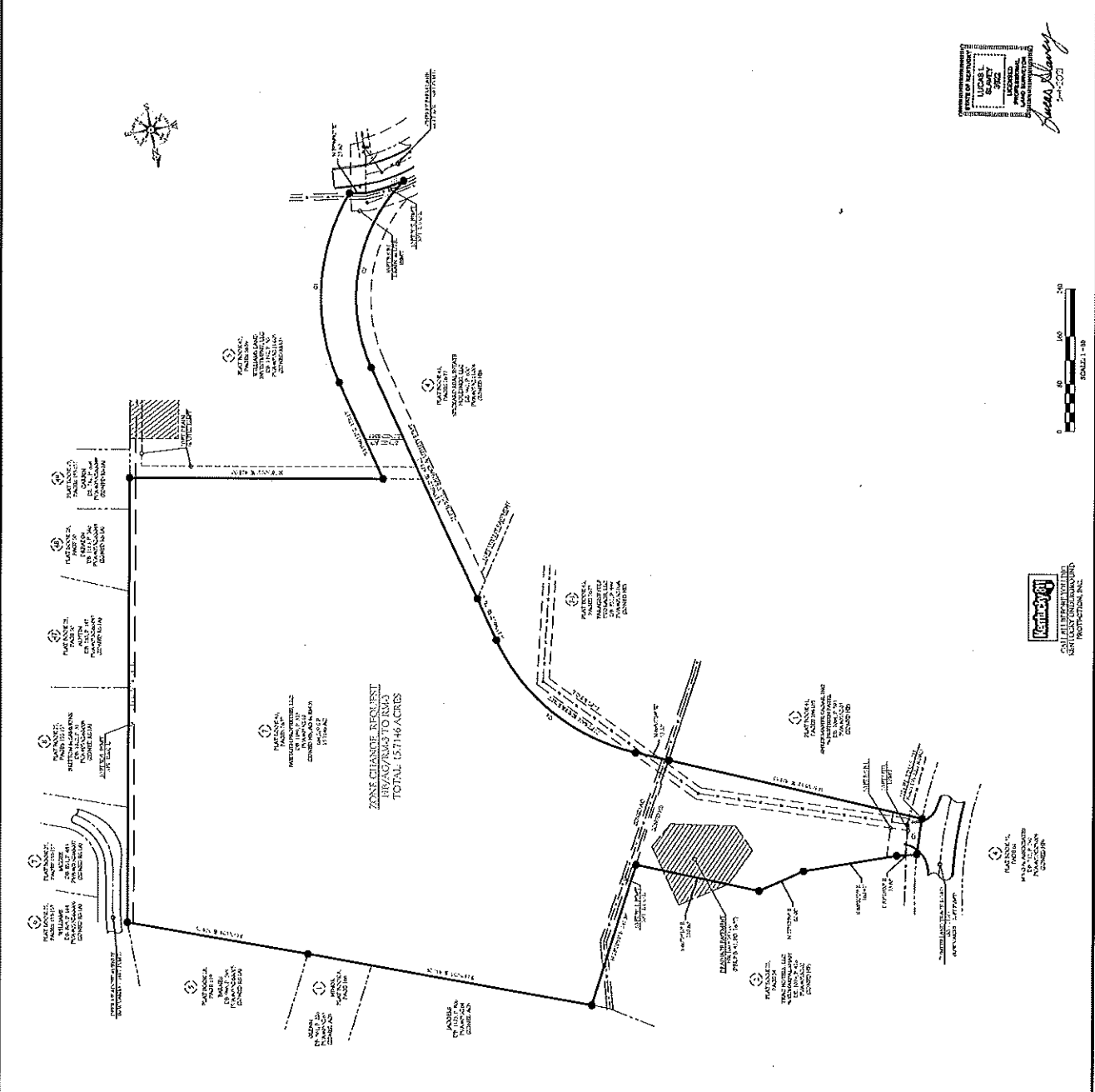

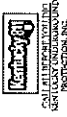
