ORDINANCE REZONING REAL ESTATE

ORDINANCE REZONING TRACTS OF LAND CONTAINING 1.45 ACRES FROM GB (GENERAL BUSINESS) AND RS-1A (SINGLE FAMILY RESIDENTIAL) TO HB (HIGHWAY BUSINESS) LOCATED AT 1218 AND 1220 BROADWAY AVENUE AND 0 COVINGTON STREET, PRESENTLY OWNED BY SPEEDWAY, LLC C/O ROBERT SWEET OF MCBRIDE DALE CLARION

Title and summary of Ordinance No. BG2020 – 34 was read. Motion was made by Wilkerson and seconded by Parrigin for first and non-binding reading of said Ordinance. Wilkerson explained the vote and discussion should only include the same dialogue as was had at the City-County Planning Commission public hearing. The representative for the applicant of Speedway, Robert Sweet of McBride Dale Clarion, made remarks and answered questions. Mr. Sweet explained Speedway purchased two additional sites to extend the Speedway business and add safeguards and screen buffers for the neighborhood, as well as some green space and a few additional parking spaces for employees only. It was added the property on Broadway Avenue, where an old car lot used to be, was part of the plan to expand the Speedway business. In addition, Mr. Sweet confirmed the plan included a freestanding sign, the closing of three (3) of the five (5) driveways that exist, and adding some greenspace along Broadway Avenue and Covington Street. Commissioner Denning made some remarks of the traffic and safety issues in that area, and Mr. Sweet replied there were two (2) driveways that would align to one (1), which shall assist with traffic and safety. At the request of Commissioner Parrigin, City-County Planning Commission Executive Director Ben Peterson explained how the Planning Commission publishes the public hearing notice, mails letters to all adjacent and additional property owners within 200 feet of the proposed rezoning, as well as publishes information of the public hearing on the Planning Commission website and social media. Peterson confirmed the staff goes above and beyond the State requirements. Paula Borland, a resident on Euclid Avenue, spoke in opposition of the rezoning and said adding more commercial property

would be negative to the neighborhood and would rather it remain residential. Mr. Sweet answered a question asked by Commissioner Parrigin related to whether Speedway could continue with the expansion on the split zoned properties, and he indicated Speedway could expand on the split zoned properties, but it was not the best option and believed the neighborhood was being more protected if it was rezoned and the development plan was implemented. Jared Cron, Speedway Project Manager made some remarks about the improvements Speedway plans to make, as well as expressed the positive effect there would be on aligning driveways with the bank. Commissioner Parrigin emphasized the City-County Planning Commission members voted in favor of the rezoning and she would like to see the improvements made to Broadway Avenue and Covington Street, as well as the alignments for safety. Commissioner Beasley-Brown made the following statement as to why she would be voting no for the rezoning: I will be voting to deny the proposed Zoning Map Amendment, docket number 2020-43-Z-BG. Based upon the testimony and documents presented in the public hearing of the Planning and Zoning Commission on September 17, 2020, the proposed Zoning Map Amendment is not consistent with the adopted FOCUS 2030 Comprehensive Plan as demonstrated by its noncompliance with the objective and action items presented in the staff report. The proposal to rezone light residential to highway business is not compatible with the area and therefore does not comply with LU-1.1.3. The proposal does not comply with LU-2.1.4, PR-1.7 or NCR-1.1.6, as the applicant did not address the existing trees located on the property which are hundreds of years old. This proposal does not comply with LU-2. The proposal is a high quality development. However, being that they tore down a historic single family home, the design standards are clearly not tailored to preserve the character of the area as required by LU-2. The proposal does not protect the nearby neighborhoods and therefore does not comply with LU-2.5. The proposed redevelopment and expansion of the existing use into a residential area will result in infill development that is NOT compatible with the surrounding area. Therefore the proposal does not comply with LU-2.5.2. Tearing down a beautiful neighborhood will not help to revitalize it. Therefore the proposed redevelopment and expansion of the existing use does not comply with LU-2.5.3. The proposal to rezone from residential to highway business does not comply with HN-1 and HN-1.3 because the proposal is not a suitable infill project for this neighborhood nor will it maintain or improve the existing character on Covington nor strengthen the nearby neighborhoods. Therefore, the proposed Zoning Map Amendment is not in agreement with the adopted FOCUS 2030 Comprehensive Plan. Further, I request that the record of my vote include the summary of evidence and testimony presented by the witnesses at the public hearing on September 17, 2020. Once the discussion ended, a roll call vote was taken.

Meisel and City Attorney Hillary Hightower explained it was brought to City staffs attention vehicle immobilization companies who boot vehicles in private parking lots do not have any standing regulations in the City's Code of Ordinances. Therefore, the City Attorney, Deputy Police Chief Brian Harrell and City Clerk Ashley Jackson reviewed other cities ordinances as a comparison, and now recommend the drafted language in Chapter 15 (Business and General Regulations). Commissioner Beasley-Brown expressed concern about the maximum \$100 charge immobilization companies could charge for booting. City Attorney Hightower reviewed the immobilization company requirements, including appropriate signage in private parking lots, and further said \$100 was deemed reasonable to cover the immobilization company's costs for materials, potential damages and staffing time. mention of who a citizen would contact if there was a complaint or violation of the ordinance, and City Attorney Hightower confirmed a citizen could contact the Police Department. Mayor Wilkerson stated he was agreeable to the staff's recommendations. Commissioner Beasley-Brown wanted to see language included in the ordinance requiring immobilization companies to respond to the violator in a timely manner, and Commissioners Denning and Parrigin agreed. After some further discussion, it was concluded to amend the ordinance to include a requirement for the immobilization company to respond within one (1) hour from the initial contact with the owner. Assistant City Manager/Chief Financial Officer Katie Schaller-Ward reviewed and recommended approval of an agreement between the City and Raymond James & Associates, Inc. to serve as the financial advisor for the City to assist with the issuance of the upcoming Kentucky Transpark General Obligation Bond. She further said to expect some further action for the Kentucky Transpark bond issue to come before the Board of

Commissioners soon. Mayor Wilkerson asked for additional discussion, and with none, a roll call vote was taken.

Municipal Order No. 2020 - 183 was approved by unanimous vote.

PRESENTATION

The Phase II Downtown Streetscape conceptual plans were presented by Vaughn & Melton Consulting Engineers, Inc. and sub consultant IBI Placemaking. Public Works Director Greg Meredith explained the project was supposed to have started in 2020, however due to COVID-19 it was delayed and would now be scheduled to start in spring 2021. He added he and Neighborhood and Community Services Director Brent Childers had one-on-one meetings with adjacent property owners and received positive feedback. Bob Nunley of Vaughn & Melton Consulting Engineers, Inc. explained the plan was to incorporate improvements from College Street to State Street and 8th Street to E. 6th Street, which would tie into what was completed in the Downtown Streetscape Phase I. In addition, there are plans to incorporate improvements at E. Main Avenue from College Street to Center Street, and E. Main Avenue from State Street to Chestnut Street. Nathan Hunter of IBI Placemaking presented some further development details, including landscaping plans.

Public Works Director Greg Meredith also reviewed the State Street proposed striping plan. He explained the overlay project planned for State Street from E. 6th Avenue to the RiverWalk Park, would include a bike lane from downtown. He added the Kentucky Transportation Cabinet (KYTC) was preparing for a Kentucky Street resurfacing, as well as a bike lane. Mayor Wilkerson requested Public Works consider not taking away any parking at State Street Baptist Church or in front of any homes, and Meredith confirmed the plan was to not take away any available parking spaces in the area. Commissioner Beasley-Brown suggested residents in the neighborhood be contacted and informed about the project.

CLOSED SESSION

Following a brief recess, the Board of Commissioners met at approximately 7:30 p.m. in closed session pursuant to KRS 61.810 (1) (c).
