Each day is an opportunity for all of us to make our City a little better place to live.


Please know that your elected officials and City employees are also working to make our beautiful City the best community it can be. We do this by following these simple principles:

2015: The Year in Review and a Look Ahead

ROADS AND TRANSPORTATION: BETTER WAYS TO GET AROUND TOWN

- A roadway capacity project was completed on Hennessy Way allowing for increased flow of traffic during peak travel times.
- A roadway safety project on Southwood Court was completed, including a curbed island to channelize traffic within the cul-de-sac.
- Improvements were made to McLellan Road, including widening of the roadway, improvements to drainage, and removal of trees and bushes along the right-of-way.



- Preliminary designs were completed for the South Central Industrial Park Connector which will allow for planning of more potential industrial development within the City.
- A new signal system was installed at Smallhouse Road and Highland Way.


 Design work was completed to remedy a highly congested roadway on Smallhouse Road from Campbell Lane to Highland Way. This project will include the widening of the roadway and will increase turning lane capacity.



- The Collegeview Sidewalk Project was completed from Old Morgantown Road to Glen Lily Road, developing a pedestrian connection, addressing drainage issues and increasing safety.
- Street cut repair standards were reviewed and revised to hold contractors accountable to a higher standard of repair.
- The total overlay budget has progressively increased by more than 60% over the past six years to better address the quality of road surface conditions throughout the City.

STRONG NEIGHBORHOODS: IMPROVING INFRASTRUCTURE, EMPOWERING PEOPLE

- Work began on the neighborhood project to drain Wakefield Pond to assist with algae and mosquito issues as well as to help with flooding along Wakefield Drive.
- The Neighborhood Improvement Program was initiated in Census Block 105.2 and includes investments of Community Development Block Grant (CDBG) and local funding to address opportunities and challenges.



 The partnership with WKU Hill House students was expanded to survey and update residents of the Reservoir Hill area for the pilot Neighborhood Improvement Program.



- New affordable housing construction was completed for Phase III of Habitat for Humanity's Durbin Estates Project, including utilities, site and street improvements and sidewalks.
- NCS Department successfully bid to host the 2015 Regional Neighborhood Network Conference which brings participants from Kentucky, Illinois, Indiana, Ohio and Tennessee to Bowling Green.
- The City assumed ownership of the Hunting Creek Cemetery and removed undergrowth, debris, and several dangerous trees.

PUBLIC SAFETY: IMPROVED TECHNOLOGY, BETTER EQUIPMENT

- New Mobile Data Computers with internal air cards were provided to the BGPD.
- CrimeView software was purchased for the BGPD and is currently being implemented for improved crime analysis.
- New tablets were distributed to the BGFD to assist with inspections and recording information while in the field.

- BGPD and BGFD are in the final stages of completing the City/County Radio
 Project that replaced the City's previous public safety radio system.
- A technical solution for crime analysis was implemented in the BGPD which can be deployed to in-car computers to enhance efforts of "Intelligence Leading Police."
- New Mobile Data Computers were installed in BGFD emergency apparatus to improve emergency response, efficiency and safety.
- A new Comprehensive Recruiting Plan was developed for the BGPD and includes specific strategies for recruiting minority candidates.



- BGFD purchased a new Mobile Fire Prevention Trailer for public education.
- The 911 Center's Enroute Software was upgraded to allow quicker reponse via emergency notification texting to mobile devices.
- Multiple structures were acquired by the City and used for hands-on training by the BGFD.
- A crime tracking application was developed by GIS staff to track and analyze trends based on geographic locations and times.



 All BGPD departmentally issued secondary weapons were replaced with a sub-compact Smith & Wesson Shield 9mm semi-automatic platform.

PARKS AND RECREATION: NEW AND IMPROVED FACILITIES

- Construction of a new soccer field in the West End is nearing completion fulfilling a need for this area.
- A major repair was completed under the CrossWinds pump house including sinkhole repairs and the addition of a new and improved pump station.
- Sixteen outdoor bleachers were replaced at various parks in order to comply with upgraded safety regulations.
- Bowling Green Parks and Recreation total participation was over 1,130,000 residents.
- Over 7,000 youth were served by the Golf Division through various schools' Physical Education classes and the City's golf academy.
- West End Neighborhood Park was relocated, received a new playground and complete renovation of the site.



• Forty-six City-owned garden plots sold out in less than 30 minutes.

- Circus Square Park received a newly constructed electrical room to more efficiently operate the fountain.
- The bathrooms, shelter, and storage area were remodeled at Hobson Grove Park along with the initiation of the construction of baseball fields and the purchase of playground equipment.
- Construction began on the Hart Indoor Training Facility for Little League baseball players at Kereiakes Park.
- Kereiakes tennis courts were resurfaced to better serve the tennis community.
- Golf Division purchased 32 new carts for the Golf Course at RiverView.



WAYS WE'RE SAVING MONEY

- Cellular Air Cards were successfully implemented for each department that requires outdoor wireless access cutting overall communication costs in half.
- Staff negotiated and amended the Kentucky Pollutant Discharge Elimination System permit for the stormwater discharges at the Butler County Landfill which will result in approximately 95% cost savings annually.



- A new City of Bowling Green smartphone app was developed in-house for better management and control at a much lower price.
- Over \$100,000 was collected from five on-line public auctions including surplus and confiscated items through GovDeals.com.



- Approximately \$10 million of the 2007A
 Bonds were refinanced resulting in a net savings to the City of approximately \$1,200,000 over the next 18 years.
- Staff secured \$2.75 million in funding through the Kentucky Environmental Cabinet for Phase 1 of the Butler County Landfill Improvements.
- Exterior lighting was replaced with LED lights at BGFD Station 3 and BGPD Headquarters to lower energy costs.
- Staff recovered over \$177,986 in City-owned property losses through outside insurance agencies, City insurers, and recovery from individuals through personal payments or court-ordered restitution.
- Parks and Recreation Department overtime was decreased to less than \$54,000.
- Approximately \$604,000 was collected in additional occupational licenses and fees through various audits.
- Russell Sims Aquatic Center operating revenues increased 13% to over \$500,000.

BETTER WAYS OF WORKING

- A new indoor guest WIFI network was established for citizens to use at various City facilities.
- A new on-line system was developed to process job postings, job applications, and applicant reviews.
- The pool of potential bidders for City projects has increased approximately 30% since the spring of 2013 to ensure competition and to achieve the best price and value for purchases greater than \$20,000.
- Four new large trucks were purchased for snow and ice removal with greater functionality than previous vehicles.
- Renovations were completed at 707 East Main to support the relocation of the NCS Department.



- The Bowling Green Parks and Recreation Master Plan was initiated with surveys and public forums to better determine the future direction of City parks.
- Building permit applications have been reformatted to reduce the amount of time and information necessary to complete the process.
- Eleven Job Development Incentive Agreements were completed, projecting 1,364 new jobs.



 A new records retention area is being developed at the City Hall Annex to provide for more storage and better overall retention of records.

BETTER SECURITY

- A new building security access system was installed and implemented at BGPD and the City Hall Main Campus and was subsequently expanded to Neighborhood and Community Services.
- On-line security training was developed and assigned to staff as the result of a recent security study and recommendations.
- Much needed renovations were completed at the City Hall Annex and the Neighborhood and Community Services buildings to better serve the public and employees.



DISTINCTIVE

- The City's FY15 Budget Document received the third consecutive Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA).
- The fourth annual Internal Services Survey was completed with a 35% response rate to rate the services received by employees during FY14.

- BGFD collected \$17,000 for the Muscular Dystrophy Association through the "Fill the Boot" campaign.
- The bi-annual National Citizen Survey was completed, reaching out to Bowling Green residents to compare City services nationally.
- The City was recertified as a "Drug-Free Workplace" through the Department of Workers' Claims and received a 5% workers' compensation premium savings of approximately \$21,891, providing approximately 75% of all funding needed to perform pre-employment, random, and post-accident drug and alcohol testing.

OUTSTANDING

- Participation in ICMA Insights Center for Performance Analytics (formerly Center for Performance Measurement) data reporting and comparison program continued for the eighth year.
- BGFD re-initiated its day long Citizens Fire Academy.



- •BGFD partnered with Toys for Tots and delivered toys to 100 kids on Christmas morning.
- The Popular Annual Financial Report (PAFR) for FY14 received the GFOA award for Outstanding Achievement.



- Public Works Department won the drainage award from the Kentucky Section of the American Public Works Association for the Covington Street Drainage Basin.
- A safety grant in the amount of approximately \$6,000 was awarded from the Kentucky League of Cities Insurance Services for 50% reimbursement on certain sidewalk repair projects and the purchase of respirators for Police and other Personal Protection Equipment for various departments.
- The Comprehensive Annual Financial Report (CAFR) received the GFOA Certificate of Excellence in financial reporting for FY14.

HIGH PERFORMING

- The City achieved the Certified City of Ethics designation from the Kentucky League of Cities (KLC).
- BGPD Communication Center was the first 911 Communication Center in Kentucky to be accredited by the Kentucky Association of Chiefs of Police.
- BGFD arson arrest rate was 71% while FBI statistics list the national average at 18.8%.

- Public Works Department achieved re-accreditation through the American Public Works Association (APWA). Bowling Green Public Works remains the only department in Kentucky to achieve this status.
- Public Works Department had no lost time injuries in FY15; the Operations Division has completed over 2,400 days without a lost time accident.

FISCAL YEAR (FY) 2016 KEY BUDGET RECOMMENDATIONS

- Compared to last year's adopted budget, revenues in FY16 are projected to increase by 2.6% for All Funds and 2.4% for General Fund.
- The City's overall expenditure budget has increased by 2.9% for FY16 and the General Fund expenditure budget has increased by 2.4% compared to the previous year.
- No local tax increases were recommended or adopted in the budget.



- The General Fund minimum reserve balance (savings) remains at 20% of revenues to better underwrite the City's financial obligations.
- There are no new financed projects proposed in FY16. The total adopted Capital Improvement Program, including debt, is approximately \$21.2 million.



- \$513,415 of CDBG and local tax dollars will fund the second year of the Neighborhood Improvement Program to make targeted improvements within a defined area. Additionally, \$40,000 of local tax dollars will be dedicated to the annual SNAP Grant Program to assist neighborhoods with smaller improvement projects.
- \$1.2 million in State funds and another \$1,272,500 in local tax revenues will be utilized to maintain streets and sidewalks as part of the City's annual overlay and reconstruction program and to continue making improvements to a segment of Smallhouse Road.
- \$827,000 in local tax revenues will fund the Stormwater Mitigation Program as well as make other stormwater improvements for the enrichment of our community livability.



 Nearly \$1.1 million will be dedicated to enhance public safety services with upgraded facilities, vehicles, equipment, and surveillance systems, including the purchase of a training simulator for vehicle fires.

The money will be used to continue the development of West End Park as well as make improvements to Lampkin and Pedigo parks and at the Russell Sims Aquatic Center in FY16.



 The City also implemented a savings program for new road projects to begin planning for future needs.
