ORDINANCE AMENDING CODE OF ORDINANCES

ORDINANCE AMENDING CHAPTER 2
(ADMINISTRATION), SUBCHAPTER 2-25
(BOWLING GREEN-WARREN COUNTY
MILITARY LIAISON BOARD) OF THE CITY OF
BOWLING GREEN CODE OF ORDINANCES TO
APPROVE CHANGES RECOMMENDED BY THE
BOWLING GREEN-WARREN COUNTY MILITARY
LIAISON BOARD

WHEREAS, the City of Bowling Green and Warren County created the Bowling Green-Warren County Military Liaison Board to promote community and local government participation in preserving and enhancing military commands and missions in the City and County; and,

WHEREAS, at its meeting on February 22, 2010, the Military Liaison Board approved recommended amendments to the Code of Ordinances dealing with board composition and the qualification of board members; and,

WHEREAS, it is in the best interests of the City to approve those recommended amendments.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

- 1. Chapter 2 (Administration) is hereby amended as follows:
 - 2-25 BOWLING GREEN-WARREN COUNTY MILITARY LIAISON BOARD.
 - 2-25.02 Membership and Terms.
- a. The Bowling Green-Warren County Military Liaison Board shall consist of ten (10) members appointed jointly by the Mayor and County Judge/Executive, with approval of the Board of Commissioners and Warren Fiscal Court. Two of those board members shall consist of the Commander of American Legion Post #23 and the Commander of VFW Post #1298. Each member shall serve a term of three (3) years with the initial appointments being staggered with three (3)

members serving a term of one (1) year, three (3) members serving a term of two (2) years, and four (4) members serving a term of three (3) years. Board members shall have a military background or be the spouse of military personnel and any person recommended for appointment may be required to document this requirement by providing copies of military discharge papers or other documentation sufficient to the City and County.

b. The Board shall also be composed of nine (9) non-voting ex-officio members named as follows: City Central Coordinator, Warren County Grants Director, Warren County DES Director, and one representative from each of the Kentucky Army National Guard, U.S. Army Reserve, U.S. Army Recruiting, U.S. Air Force Recruiting, U.S. Marine Recruiting and U.S. Navy Recruiting.

- 2. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.
- 3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.
- 4. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on March 2, 2010, and given final reading on March 16, 2010, and said Ordinance shall be in full force and effect upon signature, recordation and publication in summary pursuant to KRS Chapter 424.
