# MINUTES of SPECIAL MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held January 5, 2021

The Board of Commissioners of the City of Bowling Green, Kentucky met in special session in the Commission Chamber of City Hall, Bowling Green, Kentucky and via Lifesize video teleconference due to the Coronavirus (COVID-19) pandemic at 4:30 p.m. on January 5, 2021. Mayor Todd Alcott called the meeting to order. He made welcoming remarks and wished all a Happy New Year, as well as thanked the City Manager and his team for taking the City through a difficult year. He further read a quote inspired by Benjamin Franklin "May you be at war with all your vices, may you be at peace with all your friends and may the New Year find you to be a better person." ORDINANCE REZONING TRACTS OF LAND CONTAINING 1.45 ACRES FROM GB (GENERAL BUSINESS) AND RS-1A (SINGLE FAMILY RESIDENTIAL) TO HB (HIGHWAY BUSINESS) LOCATED AT 1218 AND 1220 BROADWAY AVENUE AND 0 COVINGTON STREET, PRESENTLY OWNED BY SPEEDWAY, LLC C/O ROBERT SWEET OF MCBRIDE DALE CLARION

Title and summary of Ordinance No. BG2020 – 34 was read by the City Clerk. Motion was made by Hill and seconded by Parrigin for the second and binding reading of said Ordinance. Meisel introduced the ordinance and explained it was a second reading. City Attorney Hillary Hightower added the developer had made some voluntary supplemental development plan conditions since the first reading in response to comments received from residents at the Planning Commission hearing and comments from a resident and Commissioners following the first reading of the Ordinance. It was

clarified the voluntary supplemental development plan conditions would be recorded with the plat and Certificate of Land Use Restrictions, and would not require approval by the City-County Planning Commission again. However, if in the future there was a request to change anything further it would require a new application and hearing from the City-County Planning Commission. Attorney David Broderick made remarks and stated the Planning Commission approved the rezoning by an 8-3 vote in favor of the proposal. He further said the plans include building a new Speedway building, which would allow for more space, aligning the Speedway entrance with American Bank's entrance, as well as aligning the Speedway entrance on Broadway to assist with congestion. Mr. Broderick indicated originally there were thirteen (13) development plan conditions, however now there were eighteen (18). Some of the additional conditions included reducing employee parking from three (3) to one (1), agreement to maintain a permanent landscape buffer and six (6) foot wooden fencing on the residential side. In response to some questions from Commissioner Parrigin, Mr. Broderick said the Kentucky Transportation Cabinet and City of Bowling Green Public Works Department worked with Speedway to assist with traffic safety issues, and gas pumps would be further off the roadway to allow for a better traffic flow in and out of the facility. Furthermore, he explained seven (7) gas pumps would be installed, and based on the needs and design, a zoning change to Highway Business (HB) was necessary. Commissioner Hill questioned the size of the new construction, signage and zoning notifications for the residents to participate in the public hearing. McBride Dale Clarion representative Robert Sweet said the building would be approximately three (3) feet larger and more attractive. City-County Planning Commission Attorney Hamp Moore and City-County Planning Commission Executive Director Ben Peterson explained there were various capabilities for residents to participate in the Planning Commission meeting, including video teleconference via Zoom and phone. Commissioner Beasley-Brown expressed gratitude of the City and Speedway working together to find a way to move forward to protect the neighborhood, allow growth and provide services. She believed it was a win/win scenario and was proud to have found solutions to the concerns. Ms. Paula Borland spoke in opposition of the rezoning and would like to see the property remain residential. Commissioner Bailey added he believed the neighborhood should be protected, but saw the need for improvements and thought Speedway had a positive plan in place. Once discussion concluded, a roll call vote was taken.
