- Clean appropriate swimwear is required. No thong swimsuits, cut-offs, or shorts with any metal fasteners will be allowed.
- We reserve the right to refuse admission to all those having an infectious disease, bandages, or those who may be under the influences of drugs, alcohol, or those exhibiting erratic behavior
- No smoking at the Russell Sims Aquatic Center. Smoking is permitted in the parking lot.
- Diaper-aged children must wear a Swim Diaper.
- 42" minimum height requirement to use water slides. No eye glasses, tee shirts, jewelry, or foreign objects allowed on water slides.
- The park may close or suspend operation due to inclement weather. Weather suspensions are a minimum of 30 minutes.
- Hours are subject to change without notification.
- Group will charge no fees, no donations will be solicited by Group, and the Group will not conduct any sales during the event.
- Replay Policy – If operations are suspended for 1 hour (that is 60 consecutive minutes), all patrons are eligible to redeem their receipt for a "REPLAY PASS" good for total paid guest. This pass is usable for any remaining normal operation day during the current season.
